### 101 Days of Summer

Attorney General Grewal, Division of Highway Traffic Safety Announced "101 Days of Summer" Traffic Safety Campaign Ahead of Busy Summer Travel Season

Three-Month Initiative Aimed at Preventing Crashes, Saving Lives on NJ Roadways

At a seaside event in Asbury Park on May 21<sup>st</sup>, Attorney General Gurbir S. Grewal and Eric Heitmann, Director of the Division of Highway Traffic Safety announced the start of a statewide campaign to enhance safety on New Jersey roads during the busy summer travel season.

Members of the federal, state, county, and local law enforcement and traffic safety communities gathered on the boardwalk outside the Asbury Park Convention Hall to support the kick-off of the "101 Days of Summer" traffic safety campaign, which will run between Memorial Day weekend and Labor Day.

"Ensuring the safety of New Jersey residents and visitors is our top priority and that means making sure our roadways are safe for all who use them, especially during the busy summer travel season," said Attorney General Grewal. "New Jersey's recreational and entertainment destinations create heavy travel demands on our roadways during the summer. We are working to ensure that New Jersey residents and visitors arrive at their destinations safely."

The time between the Memorial Day weekend and Labor Day - known as the 101 Days of Summer - is considered to be the busiest and most dangerous travel period of the year.

In New Jersey, fatal crashes, alcohol-related crashes, and young-driver crashes all occur at higher rates between Memorial Day weekend and Labor Day, according to an analysis of five-year crash statistics. In 2017 alone, 137 motor vehicle occupants, 48 pedestrians, and 5 bicyclists lost their lives in crashes on New Jersey roadways during that period – more than a third of the total lives lost that year.

## Gov. Murphy Signs Law Allowing Operation of Electric Bikes & Scooters on Roadways

Gov. Phil Murphy signed legislation Monday regulating low-speed electric scooters and e-bikes in much the same way as regular bicycles.

<u>Senate Bill 731</u> allows motorized scooters and e-bikes capable of traveling 20 miles per hour or slower to be operated on streets, highways and bicycle paths. An operator of a low-speed electric bicycle or motorized scooter will not be required to register the vehicle, furnish proof of insurance, or have a driver's license. The bill further provides that all statutes, rules, and regulations that apply to ordinary bicycles apply to low-speed electric bicycles and motorized scooters.

The primary sponsors of the bill were Sen. Linda Greenstein, Sen. Shirley Turner, Assemblyman Raj Mukherji, and Assemblyman Jamel Holley.

"Electric bicycles and motorized scooters offer a fantastic alternative to cars, and their use will serve to cut both emissions and congestion in our cities," Murphy said in a prepared statement. "As we seek to support New Jersey's Innovation Economy, this bill will help encourage a true re-imagining of urban commuting." ctrl + click here to read the entire bill S731



NJDOT & NJTPA announce nearly \$20 million in Federal grants while NJDOT & DVRPC announce more than \$5.6 million in Federal grants to improve local transportation



Safe Routes to School grants funding will help municipalities make pedestrian safety improvements

NJ Department of Transportation (NJDOT) in partnership with the North Jersey Transportation Planning Authority (NJTPA) announced in May the awarding of nearly \$20 million in 27 federal grants under the <u>Safe Routes to School (SRTS)</u> and <u>Transportation Alternatives Set-Asides</u> (TA Set-Asides) programs. And with its partnership with the Delaware Valley Regional Planning Commission (DVRPC) announced the awarding of more than \$5.6 million in 10 federal grants under the <u>Safe Routes to School (SRTS)</u> and <u>Transportation Alternatives Set-Asides</u> (TA Set-Asides) programs.

"As part of NJDOT's commitment to communities, we work with the three regional planning authorities to provide federal funding to counties and municipalities for local transportation projects that improve safety and strengthen the cultural, aesthetic, and environmental aspects of our transportation system," NJDOT Commissioner Diane Gutierrez-Scaccetti said. "The Safe Routes to School grants will provide resources to local communities throughout New Jersey to enhance our sidewalks and crosswalks to allow our children to safely walk or bike to school."

The SRTS and TA Set-Asides are both federally-funded programs. SRTS was established in 2005 to increase pedestrian safety awareness among motorists and schoolchildren. The TA Set-Asides program was established by Congress in 2012 and is funded through a set aside of the Federal-Aid Highway Program to provide funds for community-based "non-traditional" projects that strengthen the cultural, aesthetic, and environmental aspects of the nation's intermodal system.

The programs are administered by NJDOT in partnership with the NJTPA, Delaware Valley Regional Planning Commission (DVRPC) and the South Jersey Transportation Planning Organization (SJTPO). The grants

announced today are for projects within the NJTPA region. The DVRPC and SJTPO will announce their grants later this month.

#### Safe Routes to School

The Safe Routes to School program was created to encourage children, including those with disabilities, to walk and bike to school. These 11 grants totaling \$5.8 million will provide local governments within the NJTPA region the ability to make pedestrian safety improvements near K-8 schools. While the four grants totaling about \$1.9 million will provide local governments within the DVRPC region, the ability to make pedestrian safety improvements near K-8 schools.

The goal is to make bicycling and walking to school a safer and more appealing transportation alternative, thereby encouraging a healthy and active lifestyle from an early age; and to implement projects that will improve safety, and reduce traffic, fuel consumption, and air pollution in the vicinity of schools. Infrastructure improvement projects to be funded through the program include the construction of sidewalks, bikeway lanes, and multi-use paths; and the installation of new crosswalks, school-zone markings, and speed-limit signs.

#### **Transportation Alternatives Program (TAP)**

The Transportation Alternatives Set-Aside Program provides federal funds for community-based "non-traditional" projects designed to strengthen the cultural, aesthetic, and environmental aspects of the nation's intermodal system. The 16 grants totaling \$13.99 million in the NJTPA region and the six grants totaling \$3.75 million in the DVRPC region are for projects that must fall into one of the following seven categories:

- Design and construction of on-road and off-road trail facilities for pedestrians, bicyclists, and other non-motorized forms of transportation
- Conversion and use of abandoned railroad corridors for trails for pedestrians, bicyclists, and other non-motorized transportation users.
- Construction of scenic turnouts, overlooks, and viewing areas.
- Historic preservation and rehabilitation of historic transportation facilities both land and water such as building structures and canals.
- Community improvement activities, specifically: streetscaping and corridor landscaping.
- Environmental mitigation to address stormwater management, control, and water pollution prevention or abatement related to highway construction or due to highway runoff.
- Reduce vehicle-caused wildlife mortality or to restore and maintain connectivity among terrestrial or aquatic habitats.

The Transportation Alternatives Set-Aside Program provides federal funds for community-based "non-traditional" projects designed to strengthen the cultural, aesthetic, and environmental aspects of the nation's intermodal system. ### Blue Alerts Notify the Public When Police Are Injured or Killed

The Blue Alerts are delivered through FEMA's Integrated Public Alert and Warning System to notify the public of the imminent danger. It's already played a role in the capture of one cop killer.

When Newman, Calif., police officer, Ronil Singh, was murdered in December 2018, a Blue Alert was issued to notify the public of the dangers of a killer on the loose and to help apprehend the suspect.

The Blue Alert, a brief message issued via FEMA's Integrated Public Alert and Warning System (IPAWS), was issued by the California Highway Patrol in the Fresno and Merced areas where the suspect was believed to be on the run. The embedded link in the alert that contained a flyer with added information on the suspect was clicked on by more than a million cellphones within 30 minutes.

Developed by OnSolve, Blue Alert is a new addition to IPAWS to provide law enforcement officials with the ability to alert the public of injury or death of a law enforcement official. It is administered in California by the CHP, which acts on information provided by the local agency seeking to send an alert.

States can apply through FEMA to adopt Blue Alerts as they would for Amber and Silver alerts. "You take an event like the Boston Marathon bombing, although initially centered on the public, it eventually involved law enforcement, so being able to send descriptions on what to look for is invaluable," said Troy Harper, OnSolve's general manager of Public Sector. "I think it's going to help create a deeper bond between the responders and the public."

Blue Alerts are allowed to be issued in any of the following circumstances according to the FCC:

- •When a law enforcement officer is killed or seriously injured in the line of duty
- •When an officer is missing in connection with official duties
- •When there is an imminent and credible threat to kill or seriously injure a law enforcement officer. ctl + click here to read the full article

### Does New Jersey Have a Blue Alert System ????

There are two bills presently before the New Jersey Legislature, introduced in 2018, one in the Assembly (A2604) and one in the Senate (S3272). The Assembly floor amendment passed back on February 25<sup>th</sup>, while the Senate released it from committee in February but has not introduced it for a vote.

Also, NJ's bills say nothing about the use of the cell phone alerting system (IPAWS) as described in the above article and the system used for dangerous weather alerts (like the ones sent out last week warning of the tornado watch).

As the article outlined, states can apply through FEMA to adopt Blue Alerts as they would for Amber and Silver alert programs.

Some 2013-2018 Ford Explorer Police Interceptor utility vehicles equipped with a 3.7L twin independent variable camshaft timing (Ti-VCT) engine may exhibit an illuminated MIL with DTC P0420 and/or P0430.

Using a scan tool, retrieve the DTCs If P0420 and/or P0430 are the only DTCs stored in the PCM, replace the affected catalytic converter(s). If the vehicle was built on or before April 25, 2014, reprogram the PCM using release 90.02 or higher.

### **Defecating Superintendent Sues Over the Release of Mug Shot**

A former New Jersey school superintendent who pleaded guilty to defecating on another high school's track a year ago is suing the Holmdel Police Department in Federal Court for releasing his mug shot to the media.

Outlined in the federal lawsuit filed in Newark, he indicates that police violated his constitutional rights by taking the picture and then releasing it after he had been issued summonses last year.

The suit said that his due process rights were violated, alleging New Jersey law prohibits the taking of mug shots for low-level offenses. The suit seeks unspecified monetary damages.

### FAA to U.S. airports: Do not install drone countermeasures on your own

The Federal Aviation Administration told U.S. airports in a letter they could not install drone countermeasures without federal consent, warning they could pose an aviation safety risk by interfering with aircraft navigation and air navigation services.

The FAA said only federal agencies with explicit authority should install systems designed to detect and potentially destroy drones. The agency added: "There are many related efforts that are underway that will make it easier to identify drone operators."

There has been rising concern about drones near U.S. airports. In January, the FAA said 43 flights into New Jersey's Newark Liberty International Airport were required to hold after a nearby reported drone sighting.

Last year, Congress granted the Justice and Homeland Security departments authority to disable and destroy drones. The FAA told airports that the law did not "provide authority to deploy and use drone countermeasures as a standing asset to protect airports."

In April, the FAA said it was investigating a drone that hovered over Boston's Fenway Park during a Red Sox baseball game.

### Auto Care Association Highlights the Fight for Vehicle Data

New York Times - May 20, 2019

The New York Times is conducting an ongoing examination of privacy and data, and Bill Hanvey, CEO and president of the Auto Care Association, wrote about the data collected by a modern vehicle. It's about much more than the frequency of oil changes. "Your car knows when you gain weight."

There are four key points:

"Cars...know how fast we drive, where we live, how many children we have - even financial information. Connect a phone to a car, and it knows who we call and who we text. But who owns and, ultimately, controls that data? And what are carmakers doing with it?

"For almost a century, car and truck owners have been able to take their vehicles to whichever shop they choose and trust for maintenance and repair. That may be changing."

"The solution is simple. The only person who should control car data is the car owner (or lessee). He or she should be aware of the data the car transmits, have control over it, and determine who can see it."

"Carmakers have no incentive to release control of the data collected from our vehicles. Policymakers, however, have the opportunity to give drivers control - not just so that they can keep their data private but also so that they can share it with the people they want to see it. This will let car owners maintain what they've had for a century: the right to decide who fixes their car."

#### State v. Fede - Refusal to let police into the home is not criminal interference

The Court stresses that the police officers had the right to enter defendant's home under the emergency-aid doctrine, which permits warrantless entry under the circumstances like those presented in this case. Because defendant's refusal to remove the door chain did not constitute an affirmative interference for purposes of obstructing justice within the meaning of the obstruction statute, the Court reverses the judgment of the Appellate Division and vacates defendant's conviction. (A-53-17)

### State v. Vincenty - Miranda violated here where detectives failed to advise the subject of charges. \_\_ NJ \_\_ (2019)

The record reveals that the detectives failed to inform Vincenty of the charges filed against him when they read him his rights and asked him to waive his right against self-incrimination. That failure deprived Vincenty of the ability to knowingly and intelligently waive his right against self-incrimination. Pursuant to A.G.D., Vincenty's motion to suppress should have been granted. (A-40-17)

<u>State v. Rodriguez</u> - the New Jersey Supreme Court recently ruled that people sentenced to jail for a violation of NJSA 2C:40-26, driving on the revoked list following DWI or refusal convictions, must serve straight time in jail and may not be sentenced to periodic incarceration on weekends or otherwise.

<u>State v. Nelson</u> - On May 8th, the New Jersey Supreme Court ruled that a motor vehicle stop that was prolonged while the police awaited the arrival of a drug-sniffing dog was reasonable under the 4th Amendment. The Court ruled that the police had developed sufficient reasonable suspicion that drugs were in the defendant's vehicle and the defendant had declined to provide consent for a vehicle search.

The reasonable suspicion allowed the police to continue the investigative detention for a reasonable period of time to either confirm or dispell their suspicions.

### **Workshop on Traffic Calming**

Traffic calming uses physical design and other measures to improve safety for motorists, pedestrians, and cyclists.
