To add your book it will need to be saved in PDF format. For example, if you are writing your documents in Word, you can do a "Save As" and change the "Save as type" to PDF instead of Word format.

There are a lot of resources online and on www.amazon.com on how to best format your book for e-readers before uploading it. Amazon's website has tools to help you format your book, such as the "Kindle content creation tools" and "Cover creator", which can be accessed on the screen above. You can also google how to self-publish an e-book, and you will see many sites on the internet that can help you learn how to get your book self-published, and how to market it. Amazon has different rules for different countries which are all listed on their website, as well as all the directions for self-publishing e-books.
