

10/29/2018

Deputy Barton responded to a domestic dispute on State Route 78 East. After investigating the alleged incident, it was determined that the situation was only a verbal altercation and was handled without incident.

Deputy Schuerman and Sgt. Smith investigated a breaking and entering and a theft in a Sardis business. A report was taken and investigation pending.

10/30/2018

Sgt. Smith investigated a one-vehicle traffic crash on State Route 26 in Wayne Township. Investigation pending.
