B. Parker Rd. Brickwork repair:

Joely: Unfortunately this lead was too good to be true. Mr. Hanners (handyman recommended by the Meyers) blew me off. He pushed the date as to when he could look at the project and give a bid and then contacted me on the day he was supposed to be here and said he accepted 2 new big contracts and couldn't help us this year. I asked if he would consider the job once his other two contracts were complete and he never responded to me.

- ➤ I have yet to check the front electrical to see if this is working. On my 'to do' list.
- Now that we know who fixed the monument on the Dillion entrance, do we know who they used to do the job?? If not, I can contact them and ask.

<u>Joely:</u>

It was brought up at last month's meeting the question of necessity of voting on the previous year's homeowners meeting minutes when they have already been voted on and approved by the board (11 months prior).

CD-matures on October 31, 2022-Kathy met with Bellco to discuss interest rate increase. We have a 10 day grace period before reinvesting. The amount needed for the tennis court repairs will be put in a 6 month cd and the rest in a 12 month cd.

Lien on 14114 E. Layton Drive-Our attorney is helping with the paperwork and filing of the lien. Currently the amount due is \$732 to include filing and attorney fees and penalties. The owner has received a letter that states what the fees will be.
