CREATING CLOUDS TO STOP GLOBAL WARMING COULD WREAK HAVOC

The U.S. government office that oversees federally funded climate research has recommended studies into two areas of geoengineering research, marking the first time scientists in the executive branch have formally called for studies in the controversial field. USA TODAY

To counteract global warming, humans may someday consider spraying sulfur dioxide into the atmosphere to form clouds — and artificially cool the Earth.

The idea behind the process, known as geoengineering, is to keep global warming under control — with the ideal solution still being a reduction in the emissions of greenhouse gases.

However, suddenly stopping that spraying would have a "devastating" global impact on animals and plants, potentially even leading to extinction, according to the first study on the potential biological impacts of climate intervention.

"Rapid warming after stopping geoengineering would be a huge threat to the natural environment and biodiversity," said study coauthor Alan Robock of Rutgers University. "If geoengineering ever stopped abruptly, it would be devastating, so you would have to be sure that it could be stopped gradually, and it is easy to think of scenarios that would prevent that."

Rapid warming forced animals to move. But even if they could move fast enough, they might not be able find places with enough food to survive, the study said.

"Plants, of course, can't move reasonably at all. Some animals can move and some can't," Robock said.

If stratospheric climate geoengineering is deployed but not sustained, its impacts on species and communities could be far worse than the damage averted.

While animals would be able to adapt to the cooling affects of the spraying, if it's stopped the warming would ramp up too fast for the animals to keep up.

Researchers in the study used computer models to simulate what would happen if geoengineering led to climate cooling and then what would happen if the geoengineering stopped suddenly.

Starting geoengineering then suddenly stopping it isn't necessarily far-fetched.

"Imagine large droughts or floods around the world that could be blamed on geoengineering, and demands that it stop. Can we ever risk that?," Robock said.

The idea behind this type of geoengineering would be to create a sulfuric acid cloud in the upper atmosphere that's similar to what volcanic eruptions produce, Robock said. The clouds, formed after airplanes spray sulfur dioxide, would reflect solar radiation and thereby cool the planet.

Geoengineering takes its cue from the natural experiment that actually had made the only recent dent in global warming's rise in the last few decades — the 1991 eruption of Mount Pinatubo in the Philippines, which blasted more than 15 million tons of sulfur dioxide 21 miles high, straight into the stratosphere.

The stratosphere suspended those sulfur particles in the air worldwide, where the haze they created scattered and reflected sunlight away from the Earth and cooled global atmospheric temperatures nearly 0.7 to 0.9 degrees Fahrenheit in 1992 and 1993,

before finally washing out, according to NASA's Goddard Institute for Space Studies estimates.

But the airplanes spraying the sulfur dioxide would have to continuously fly into the upper atmosphere to maintain the cloud because it would last only about a year if spraying stopped, Robock said. The airplane-spraying technology may be developed within a decade or two, he added.

As detailed in the 2016 Paris climate change agreement, the world's nations have pledged to ensure that global warming stays well below 3.6 degrees above industrial levels.

This method of geoengineering is one of two primary ways humans could counteract man-made climate change, with the other being trying to remove the carbon dioxide that's already in the atmosphere.

Both procedures remain theoretical and untested at this point.

The study was published in the peer-reviewed British journal Nature Ecology & Evolution.

WEATHER CONTROL AS A COLD WAR WEAPON

On November 13, 1946 pilot Curtis Talbot, working for the General Electric Research Laboratory, climbed to an altitude of 14,000 feet about 30 miles east of Schenectady, New York. Talbot, along with scientist Dr. Vincent J. Schaefer, released three pounds of dry ice (frozen carbon dioxide) into the clouds. As they turned south, Dr. Schaefer noted, "I looked toward the rear and was thrilled to see long streamers of snow falling from the base of the cloud through which we had just passed. I shouted to Curt to swing around, and as we did so we passed through a mass of glistening snow crystals! Needless to say, we were quite excited." They had created the world's first human-made snowstorm.

After the experiments of G.E.'s Research Laboratory, there was a feeling that humanity might finally be able to control one of the greatest variables of life on earth. And, as Cold War tensions heightened, weather control was seen by the United States as a potential weapon that could be even more devastating than nuclear warfare.

In August of 1953 the United States formed the President's Advisory Committee on Weather Control. Its stated purpose was to determine the effectiveness of weather modification procedures and the extent to which the government should engage in such activities. Methods that were envisioned by both American and Soviet scientists—and

openly discussed in the media during the mid-1950s— included using colored pigments on the polar ice caps to melt them and unleash devastating floods, releasing large quantities of dust into the stratosphere creating precipitation on demand, and even building a dam fitted with thousands of nuclear powered pumps across the Bering Straits. This dam, envisioned by a Russian engineer named Arkady Borisovich Markin would redirect the waters of the Pacific Ocean, which would theoretically raise temperatures in cities like New York and London. Markin's stated purpose was to "relieve the severe cold of the northern hemisphere" but American scientists worried about such weather control as a means to cause flooding.

The December 11, 1950 Charleston Daily Mail (Charleston, WV) ran a short article quoting Dr. Irving Langmuir, who had worked with Dr. Vincent J. Schaefer during those early experiments conducted for the G.E. Research Laboratory:

"Rainmaking" or weather control can be as powerful a war weapon as the atom bomb, a Nobel prize winning physicist said today.

Dr. Irving Langmuir, pioneer in "rainmaking," said the government should seize on the phenomenon of weather control as it did on atomic energy when Albert Einstein told the late President Roosevelt in 1939 of the potential power of an atom-splitting weapon.

"In the amount of energy liberated, the effect of 30 milligrams of silver iodide under optimum conditions equals that of one atomic bomb," Langmuir said.

In 1953 Captain Howard T. Orville was chairman of the President's Advisory Committee on Weather Control. Captain Orville was quoted widely in American newspapers and popular magazines about how the United States might use this control of the skies to its advantage. The May 28, 1954 cover of Collier's magazine showed a man quite literally changing the seasons by a system of levers and push buttons. As the article noted, in an age of atomic weapons and supersonic flight, anything seemed possible for the latter half of the 20th century. The cover story was written by Captain Orville.

A weather station in southeast Texas spots a threatening cloud formation moving toward Waco on its radar screen; the shape of the cloud indicates a tornado may be building up. An urgent warning is sent to Weather Control Headquarters. Back comes an order for aircraft to dissipate the cloud. And less than an hour after the incipient tornado was first sighted, the aircraft radios back: Mission accomplished. The storm was broken up; there was no loss of life, no property damage.

This hypothetical destruction of a tornado in its infancy may sound fantastic today, but it could well become a reality within 40 years. In this age of the H-bomb and supersonic flight, it is quite possible that science will find ways not only to dissipate incipient tornadoes and hurricanes, but to influence all our weather to a degree that staggers the imagination.

Indeed, if investigation of weather control receives the public support and funds for research which its importance merits, we may be able eventually to make weather almost to order.

An Associated Press article by science reporter Frank Carey, which ran in the July 6, 1954 edition of Minnesota's Brainerd Daily Dispatch, sought to explain why weather control would offer a unique strategic advantage to the United States:

It may someday be possible to cause torrents of rain over Russia by seeding clouds moving toward the Soviet Union.

Or it may be possible — if an opposite effect is desired — to cause destructive droughts which dry up food crops by "overseeding" those same clouds.

And fortunately for the United States, Russia could do little to retaliate because most weather moves from west to east.

Dr. Edward Teller, the "father of the H-bomb" testified in 1958 in front of the Senate Military Preparedness Subcommittee that he was "more confident of getting to the moon than changing the weather, but the latter is a possibility. I would not be surprised if accomplished it in five years or failed to do it in the next 50." In a January 1, 1958, article in

the Pasadena Star-News Captain Orville warned that "if an unfriendly nation solves the problem of weather control and gets into the position to control the large-scale weather patterns before we can, the results could be even more disastrous than nuclear warfare."

The May 25, 1958, issue of The American Weekly ran an article by Frances Leighton using information from Captain Howard T. Orville. The article, in no uncertain terms, described a race to see who would control the earth's thermometers. The illustration that ran with the piece pictured an ominous looking satellite which could "focus sunlight to melt the ice in frozen harbors or thaw frosted crops — or scorch enemy cities."

Behind the scenes, while statesmen argue policies and engineers build space satellites, other men are working day and night. They are quiet men, so little known to the public that the magnitude of their job, when you first hear of it, staggers the imagination. Their object is to control the weather and change the face of the world.

Some of these men are Americans. Others are Russians. The first skirmishes of an undeclared cold war between them already have been fought. Unless a peace is achieved the war's end will determine whether Russia or the United States rules the earth's thermometers.

Efforts to control the weather, however, would find skeptics in the U.S. National Research Council, which published a 1964 report:

We conclude that the initiation of large-scale operational weather modification programs would be premature. Many fundamental problems must be answered first....We believe that the patient investigation of atmospheric processes coupled with an exploration of the technical applications may eventually lead to useful weather modification, but we emphasize that the time-scale required for success may be measured in decades.

Here, now, is the update (text only) which came with no headline or title, and appears to be a transcript from the Shreveport station's newscast:

A scientist now confirms that the United States military funded research which led to a patent suspected of making so-called "chemtrails" in our skies. In this follow-up report, investigative reporter Jeff Ferrell also discovered a U.S. Air Force manual called "Owning the Weather in 2025," which describes the very same approach.

Ferrell's original report aired on KSLA News 12, the CBS-TV affiliate in Shreveport, Louisiana where he works as a reporter and anchor. The story attracted attention from hundreds of people across the country and Canada. They watched it on YouTube, Google Video and a host of other web sites that posted the story. In turn, those viewers began emailing and calling the station.

While Ferrell immediately began investigating for a follow-up report, the station's interest in the subject waned. So, here's what he found out in his independent research:

Story update by reporter Jeff Ferrell...

"I learned about U.S. Patent #: 5,003,186, titled `Stratospheric Welsbach Seeding for Reduction of Global Warming," better known by chemtrail researchers as "The Welsbach Patent."

The patent describes putting metallic particles like aluminum and barium into jet fuel. Then, exhaust from the jet engine seeds the stratosphere. In turn, those small metallic particles serve a dual purpose by: 1) reflecting incoming light back into space and 2.) helping convert the warmth below into infra-red waves, allowing them to escape from the earth's atmosphere.

"It turned out that it seemed to work and so that's why we had applied for a patent," said patent co-inventor David Chang. Chang confirmed that the U.S. military did fund that research while he worked at Hughes Aircraft, an aerospace giant at the time. It would later downsize considerably and evolve into Direct-TV, which required some of the very same kinds of research and development.

In fact, Chang described several other military-funded projects where jet engine exhaust dispersed metallic particles into the atmosphere. "For instance, we were using it to develop targets for laser range finders," continued Chang.

I then learned about that U.S. Air Force document titled, "Owning the Weather in 2025." it details weather modification for war-fighting and describes putting carbon dust into jet fuel for dispersal as the quote, 'most convenient, safe and cost effective method," just as the Welsbach Patent explained. That method is described on page 15 of the Air Force report, originally written in 1996 as a study paper.

In September of 2002, then-Secretary of State Colin Powell even told a United Nations World Summit in South Africa quote, "we are committed to a billion-dollar program to develop and deploy advanced technologies to mitigate greenhouse-gas emissions." Powell never fully elaborated.

And few may remember that the U.S. military used covert weather modification in the past. During the Vietnam War a top secret mission called ?Operation Popeye,? seeded clouds over the Ho Chi Minh Trail to create floods and wash out the enemy's supply routes. Reporter Jack Anderson is credited with breaking that story back in 1971.

A Discovery Channel program, which first aired in February 2007, investigated so-called Chemtrails, describing them as contrail formations that persist in the skies for hours after a jet passes. But the military refused them access to jet fuel for testing.

"I suspect it may be some sort of weather control," said Stamps, Arkansas resident Bill Nichols in our first report on the subject, which aired on KSLA News 12.

Nichols handed us a mason jar with a sample inside containing water and ?other? material collected recently from his back yard. Independent testing at a Shreveport, LA lab did show high levels of barium, a hallmark of other chemtrail testing. Louisiana regulators described such a reading as unusual, but very difficult to prove its source.

Chemtrail skeptics argue barium is used very often commercially for everything from mining to oil drilling. But Chang told me that's 'exactly' why they considered such material safe to use in our skies as a welsbach particle.

But, no one has yet to officially confirm a direct connection between these alleged chemtrails and the U.S. military. Such a discovery is the 'Holy Grail' of chemtrail researchers. Such a revelation, if there is indeed such a covert program in existence at all, would require someone to step forward and potentially risk court martial or legal action. Until then, the guessing and the waiting continue.

Chemtrails, Nanoaluminum and Neurodegenerative and Neurodevelopmental Effects

The Internet is littered with stories of "chemtrails" and geoengineering to combat "global warming" and until recently I took these stories with a grain of salt. One of the main reasons for my skepticism was that I rarely saw what they were describing in the skies. But over the past several years I have notice a great number of these trails and I have to admit they are not like the contrails I grew up seeing in the skies. They are extensive, quite broad, are laid in a definite pattern and slowly evolve into artificial clouds. Of particular concern is that there are now so many -dozens every day are littering the skies.

My major concern is that there is evidence that they are spraying tons of nanosized aluminum compounds. It has been demonstrated in the scientific and medical literature that nanosized particles are infinitely more reactive and induce intense inflammation in a number of tissues. Of special concern is the effect of these nanoparticles on the brain and spinal cord, as a growing list of neurodegenerative diseases, including Alzheimer's dementia, Parkinson's disease and Lou Gehrig's disease (ALS) are strongly related to exposure to environmental aluminum.

Nanoparticles of aluminum are not only infinitely more inflammatory, they also easily penetrate the brain by a number of routes, including

the blood and olfactory nerves (the smell nerves in the nose). Studies have shown that these particles pass along the olfactory neural tracts, which connect directly to the area of the brain that is not only most effected by Alzheimer's disease, but also the earliest affected in the course of the disease. It also has the highest level of brain aluminum in Alzheimer's cases.

The intranasal route of exposure makes spraying of massive amounts of nanoaluminum into the skies especially hazardous, as it will be inhaled by people of all ages, including babies and small children for many hours. We know that older people have the greatest reaction to this airborne aluminum. Because of the nanosizing of the aluminum particles being used, home filtering system will not remove the aluminum, thus prolonging exposure, even indoors.

In addition to inhaling nanoaluminum, such spraying will saturate the ground, water and vegetation with high levels of aluminum. Normally, aluminum is poorly absorbed from the GI tract, but nanoaluminum is absorbed in much higher amounts. This absorbed aluminum has been shown to be distributed to a number of organs and tissues including the brain and spinal cord. Inhaling this environmentally suspended nanoaluminum will also produce tremendous inflammatory reaction within the lungs, which will pose a significant hazard to children and adults with asthma and pulmonary diseases.

I pray that the pilots who are spraying this dangerous substance fully understand that they are destroying the life and health of their families as well. This is also true of our political officials. Once the soil, plants and water sources are heavily contaminated there will be no way to reverse the damage that has been done.

Steps need to be taken now to prevent an impending health disaster of enormous proportions if this project is not stopped immediately. Otherwise we will see an explosive increase in neurodegenerative diseases occurring in adults and the elderly in unprecedented rates as well as neurodevelopmental disorders in our children. We are already seeing a dramatic increase in these neurological disorders and it is occurring in younger people than ever before.

The US Senate is considering funding for albedo modification geoengineering experiments – pumping particles or aerosols into the stratosphere, to reflect sunlight back into space, and counter the alleged impact of elevated CO2 levels on global climate.

To fight global warming, Senate calls for study of making Earth reflect more light

Budgetmakers in the U.S. Senate want the Department of Energy (DOE) to study the possibility of making Earth reflect more sunlight into space to fight global warming. Earth's reflectivity is known as its albedo, and the request to study "albedo modification" comes in the details of a proposed spending bill passed by the Senate appropriations committee to fund DOE, the Army Corps of Engineers, and related agencies for fiscal year 2017, which begins 1 October. The bill does not specify how much money should be spent on the research.

Critics argue that albedo modification and other "geoengineering" schemes are risky and would discourage nations from trying to reduce their emissions of carbon dioxide, the heat-trapping gas that comes from the burning of fossil fuels and that is causing global warming by absorbing increasing amounts of energy from sunlight. Still, climate researchers say they should find out what its potential of albedo modification might be.

"The recommendation is great," says Joyce Penner, an atmospheric scientist at the University of Michigan, Ann Arbor. Albedo modification "is not a solution to global warming, it is only a way to avoid, perhaps, a tipping point in the climate." David Keith, an atmospheric physicist at Harvard University, says, "Ignorance is not a good basis for making decisions, so learning more about this is extremely valuable even if we find out that it will never work." Keith adds, however, that the few existing studies suggest albedo modification could help ameliorate some effects of global warming.

The call for further research comes in a bill that would provide \$5.4 billion for DOE's Office of Science next year. It also builds on the recommendations of a February 2015 report from the National Academy of Sciences (NAS) entitled Climate Intervention: Reflecting Sunlight to Cool Earth. That report warned explicitly that albedo modification shouldn't be deployed now because the risks and benefits were far too uncertain. Still, the committee urged further research to find out what those risks and benefits might be.

A dark, oily substance appeared on cars and homes in Harrison Township, Michigan on Feb. 15, 2016. The fire department stated that the substance was not a fire hazard.

The fire department came by on Tuesday and inspected the scene. "It was an ash type of substance with a little bit on an oily consistency to it," Harrison Township Fire Department Chief Michael Lopez told ABC News.

"It appears to have fallen straight down," he added, noting that the substance was only found on the roofs of cars and homes, and not splattered across the sides.

This was the first instance of this substance appearing that Lopez could recall.

The fire department did not do any chemical analyses but was able to determine that the substance was not a fire hazard and turned over the situation to the airbase.

Schlutow said he believes the substance might have come from the airbase, as it is only a few miles away. However, in a press release today, the Selfridge Air National Guard Base stated that "there is no

As the article reveals, "the Michigan Department of Environmental Quality noted from microscopic examination" that the air-drop material "consists of a mixture of particles in dark clumps ... that morphologically resembles plant material, including leaves, seeds and fruit skins make up the majority of the sample....When coal fly ash falls to Earth, its typically dark gray color absorbs sunlight and enhances global warming. Three samples of air-drop material were analyzed independently by inductively coupled plasma mass spectrometry (ICP-MS), including one sample of which was collected and analyzed by the Michigan Department of Environmental Quality." One sample was also analyzed by scanning electron microscopy (SEM) with energy dispersive X-ray (EDX) analysis. These laboratory test results show evidence of coal fly ash and salt in the material dropped from an aircraft over Harrison Township.

Dr. Herndon reports that "patterns of quasi-circular holes, sometimes called 'cryoconite holes' are observed on ablating glacier surfaces worldwide; these holes resemble the distribution pattern of the airdrop material." Due to its dark color, natural cryoconite — windblown dust made up of soot, rock particles and microbes found on glaciers — absorbs sunlight and melts its way into glacier ice. Based on the resemblance between the air-drop material and cryoconite, Dr. Herndon concludes that "the air-drop material is synthetic cryoconite, or proto-cryoconite, whose purpose is to melt glacial ice. That explanation is consistent with the now near-daily, near-global

spraying of a particulate substance, evidenced as coal fly ash, into the troposphere which has the effect of causing global warming....Yet the consequences of this near-global weather/climate modification geoengineering activity have not been taken into account by any of the climate change models evaluated by the United Nations' Intergovernmental Panel on Climate Change (IPCC), a fact that calls into question not only the findings of that organization, but its moral authority as well."

The article recommends that "Scientists worldwide should call for, and indeed demand, a full and open investigation into these covert geoengineering activities whose potential impacts on Earth's climate system, the integrity of Earth's biota, and on human health may prove to be extremely hazardous."

UK GOVERNMENT PROPOSED CHEMTRAILS/GEOENGINEERING AS

EARLY AS 1970-WITH U.N. APPROVAL

Parliamentary records confirm that the British government considered using cirrus clouds as a means of climate modification as early as 1970. In those days, climatologists thought that the climate was cooling and sought ways to warm it. Geoffrey Johnson Smith MP said:

'to counteract the cooling effect of atmospheric dust the more jets there are in the atmosphere emitting heat-producing carbon dioxide the better, but some scientists, not all, hold the view that jet contrails—vapour trails as we usually call them—because they can lead to the extensive formation of cirrus clouds, could increase the cloud cover and thus effectively cut off the sun's rays and reduce the earth's temperature'.1

The military already had secret devices for creating contrails as early as the 1950s, as the National Archives at Kew reveal. One document is called 'Artificial Contrail Generator'. It includes information on 'Artificial vapour trails: contrail suppression equipment; vapour trails from Hunter aircraft at 50,000ft as seen from the ground, and from another aircraft flying at 8,000ft'.2

Think about it. Fake contrails could be made at altitudes as low as 8,000 ft. Disturbingly, the contrail generators were tested at the UK's biochemical warfare laboratory, Porton Down, which sprayed chemicals on the British public intermittently from 1940 to 1979 in 'trials'.3

Normal, water-based contrails (with no chemical additives) can only form under certain conditions, in temperatures below -40oc, at altitudes above 24,000 ft. or more, and in relative humidity of 70 percent. As NASA studies dating back to the 1970s conclude, water-

based persistent contrails—or manmade cirrus—only occurred in even more specific conditions: at higher altitudes and lower temperatures. The cirrus lasted for two-hours maximum.4

Take a look at the skies today. They are often covered in jetproduced cirrus all year round, in all temperatures and at all altitudes. The clouds last all day and occlude clear skies. That is because the Anglo-American governments are involved in a programme called 'owning the weather', which got Congressional funding in 1997.5

In 2010, the Minister of State for Energy and Climate Change, Joan Ruddock, admitted in a Parliamentary hearing that the UK government were financing sulphur-based 'low level cloud development'.6

The vast majority of jets generating persistent trails are not commercial jets. They are specially-built with afterburners designed to raise the relative humidity of the atmosphere to make persistent trails easier to form. Nanoparticles are released in vaporised form for the water particles to adhere to.7

In the preceding years, the government received proposals from engineers and scientists. John Gorman, Chartered Engineer, wrote: 'it would be nice to investigate the possibilities of injecting the fuel/additive mixture into an afterburner', referring to submicron silica particles. Scientist John C.D. Nissen suggested three geoengineering proposals to the government, two of which are: '1) creating stratospheric clouds – using precursor injection to generate aerosols; 2) creating contrails – using an additive to aircraft fuel'.8

Were their ideas rejected because the military are already doing it with the 'owning the weather' programme? A UK Ministry of Defence paper out to the year 2040 states: 'Weather modification will continue to be explored'.9

Most frightening is the fact that governments have the United Nations (UN)'s approval to do these things, as long as they pretend it is not for warfare purposes. In 1962, over a decade before the UN attempted to ban weather warfare, General Assembly Resolution 1721 stated:

'The General Assembly,

Noting with gratification the marked progress for meteorological science and technology opened up by the advances in outer space,

Convinced of the world-wide benefits to be derived from international co-operation in weather research and analysis,

- 1. Recommends to all Member States and to the World Meteorological Organization and other appropriate specialized agencies the early and comprehensive study, in the light of developments in outer space, of measures;
- (a) To advance the state of atmospheric science and technology so as to provide greater knowledge of basic physical forces affecting climate and the possibility of large-scale weather modification'.10

Produce research that advances solar geoengineering's science and technology frontier, publishing high-impact papers, and disseminating ideas that are taken up by other researchers and government research programs.

Track 1: Advancing Science and Technology

Develop novel solid aerosols that might:

reduce or even reverse ozone loss by neutralizing stratospheric chlorine,

Develop methods to accurately estimate the radiative forcing from solar geoengineering using existing observing systems and, where appropriate, perform conceptual development of new observing systems.

Develop field experiments that could enable in situ tests of chemistry and aerosol dynamics.

Track 2: Assessing Efficacy and Risks

Harvard's Solar Geoengineering Research Program will devote most of its effort to scientific research to improve the understanding of the risks of solar geoengineering (e.g., health impacts) and of its efficacy in reducing climate risks (e.g., reducing sea level rise or extreme events). Specific examples include:

Understand the interaction of solar geoengineering with the carbon cycle.

Understand historical analogs such as the impact of volcanic eruptions on extreme precipitation or on the mass-balance of the Greenland icecap.

Understand the environmental risks that arise once materials are introduced into the stratosphere descend into the lower atmosphere.

Understand the extent to which solar geoengineering reduces extreme temperatures and to quantify the resulting health and welfare benefits.

Track 3: Laying out Governance Options and Social Implications

The largest challenge for solar geoengineering is not the technology itself, but rather the governance of its testing and possible deployment in a divided, multipolar world. Hargard's Solar Geoengineering Research Program will support a diverse range of research in the social sciences. Examples include:

Research public perceptions and risk attitudes; e.g., use survey methods to explore how knowledge about solar geoengineering influences people's willingness to commit to emissions reduction.

Address concerns that solar geoengineering could reduce incentives to mitigate; e.g., explore the possibility of novel "Climate Clubs," in which a coalition of nations requires members to commit to major emissions reductions as a condition of participating in the decision-making process regarding whether and how much solar geoengineering should be deployed.

Fund at least two country studies to engage scientists and decisionmakers in the Philippines and one other developing country in research on the risks, benefits, and governance of solar geoengineering.

Crosscutting principles

Open access: Full transparency with open-access publications and liberal data sharing. Discourage patents and any form of IP protection.

Collaborative: Work with researchers within Harvard and across the world. Continue the successful visiting scholars program that facilitates outside collaborators, and encourage SGRP researchers to spend time abroad.

Public Engagement: Inform the public in ways that empowers citizens to engage in the discussion around solar geoengineering.

Policy-relevant: Actively work on policy-relevant research questions and then 'translate' the resulting research into publicly accessible documents.
