Public Notice of this meeting was sent to the Daily Journal for publication as prescribed by law. Notice was also posted on the Fire District website. All requirements of the Open Public Meeting Act have been achieved for this meeting in compliance with the Sunshine Law.

September 2024 meeting minutes were distributed for review via email prior to meeting. Members approved the minutes.

Motion to accept made by Elizabeth Hand and seconded by Hansel Torriero . All in favor.

- ~Budget discussion with accountant Tonya Devito:
 - Cap will stay below 2%
 - Preliminary numbers from Chief Hand distributed to Commission and Acct.
 - Tonya asked for % of yes votes from the election to approve truck purchase. Chairman will obtain.
 - \$5,155 left the the cap bank levy (2022) was discussed and options will be considered
 - Vehicle list needs to be checked by Chief Hand
 - First truck payment will be due in March 2025(\$34,185.48)
 - Proposed increase of \$1,000 each year to Capital over the next ten years will allow for the tanker refurbish process.
 - Ford Scott fee will increase 10% next year
 - Tonya will work the numbers and return to the next meeting.

- ~ Community Oil bills had some discrepancies. Treasurer spoke with the them and believes it has been squared away
- ~ Chairman will look into the affidavit of publication of the audit certification.
- \sim Current budget line for Personnel equipment is still waiting for the state grant to pay out. That line item is currently in the negative -2507.00
- ~Discussion held about the legal fees from the truck purchase. We may need to move monies around to cover in Nov.
- ~ SJ Welding acct has a \$222.00 credit. Will be used for future bills.

Explanation of bills:

- ~Clean Energy is for solar/electric
- ~ Atlantic County FF assoc was for the live burn training
- ~Dorothy Gale Roofing was for second repair of the firehouse roof
- ~Riggins was for fuel
- ~SJ Welding was for 02
- ~VCI bill 3,725.91 was for AC repair of 1273, second bill for 549.67 is an electrical issue that the Chief is going to discuss with them because it should be covered with warranty. That bill will be held for payment.

Chairman Frick called to vacate Commissioner Pietrosante from her position due to the violation of Bi-Law Article 3 paragraph 4:

Any elected member of the Weymouth Township Fire District #1 who misses three(3) consecutive meetings without notifying either the Chairman or Secretary may be dismissed from

the Commission by the remaining members. In Order for the Commission to dismiss an elected member after missing three meetings, the majority vote must be at least sixty-six percent of the remaining members.

Motion was made to remove Tatiana Pietrosante from her position by Elizabeth Hand. It was seconded by Donnel Ruga and all present members voted in the affirmative.

Secretary Ruga will draft a letter of notification on business letterhead and send it to Tatiana Pietrosante in a timely fashion.

Question was raised as to if T. Pietrosante completed her Financial Disclosure Form for the State.
