#### 5. LANDSCAPING

- A. Report from BrightView Landscape Services
  - 1. Monthly Reports
  - 2. Water Waste Mitigation Activities
    - Brightview provided their evaluation of the water use by month comparing from last year.
- B. Update on improvement projects for 2020
  - 1. Xeriscaping Project Phase II
    - Management advised the project has been submitted to SNWA for approval.
  - 2. Tree Trimming
    - \$31,500 trimming of 175 trees and \$2,625 removal of 21 dead trees. The Board took no action as further details of location, style of tree and tree size are needed to approve the proposals.
- C. Volunteer Landscape Advisory Committee Presentation and Recommendations

  Bruce Litchfield and Jean Capillupo presented a power point presentation of the current condition of all the vegetation along the parkway and provided recommendation for the Board.

## 6. OLD BUSINESS

A. Proposal for Irrigation Oversight

Management advise that she is working with the committee to determine a meter for Andrew Chase to review to provide a sample of his work to consider. No further action was taken.

A. 2020 - Proposal for Budget Committee for adoption

There was no further discussion, motion passed with all in favor. Management will distribute the budget to all the commercial members and association.

  4.3, 4.4, and 4.5. Mark West made the motion to approve the update to the by-laws as presented. Joe Lightowler seconded the motion. After further discussion, the motion was carried with all in favor.

  Arthur Schuetz made the motion postpone the approval and create a committee to review the contract term and Board expectation of management. Arthur Schuetz, Sheryl Cordero and Shirley lodice volunteered for the committee. Larry Orlov seconded the motion. After further discussion, the motion was carried with all in favor.
