This Amendment to Declaration, made on the <u>5th day</u> of January, 1987, by Barrow-Safrit, Inc., a North Carolina corporation, hereinafter referred to as the "Declarant"; WITNESSETH:

THAT WHEREAS, Ivy Commons, a North Carolina general partnership executed and caused to be recorded in the Wake County Registry in Book 3484, Page 974, an instrument entitled "Declaration of Ivy Commons Condominium", as amended by instrument recorded in Book 3654, Page 384 of the Wake County Registry, both documents herein collectively referred to as the "Declaration";

whereas, by deeds recorded in Book 3674, Page 101 and Book 3674, Fage 106, both of the Wake County the rights of Declarant under the Declaration were transferred from Ivy Commons partnership, to Barray Safrat, And Inc.; and

whereas, Section 31 of the Declaration provided that the Declarant, so long as it controls the Board, may amend this Declaration without the consent of the owners in order to attach an architect's statement that the buildings located on the property have been constructed in conformance with the Architectural Plans.

Rice certifying that Buildings 4, 5, 7 and
