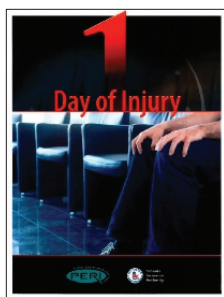

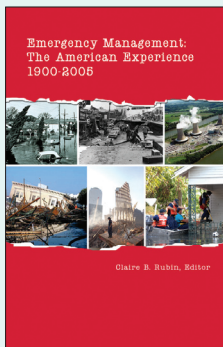

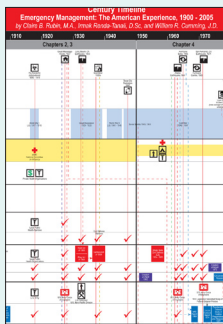
## Emergency Management: The American Experience 1900-2005

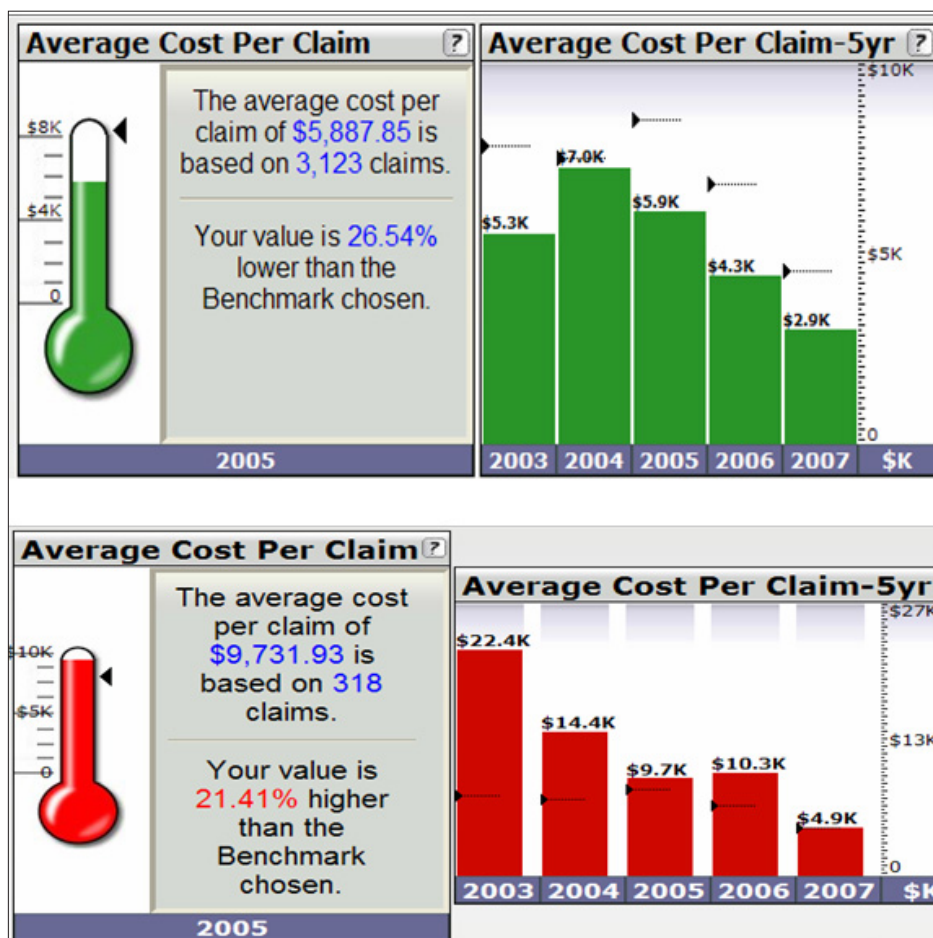

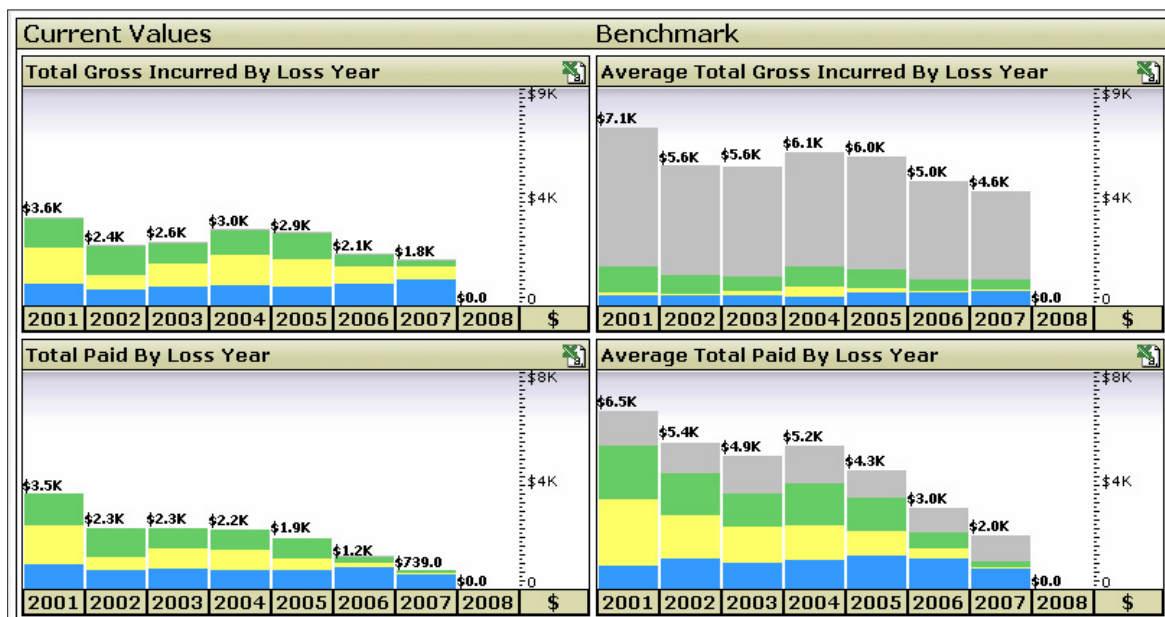
Green means your claims are below the benchmark and Red indicates your claims are higher than the benchmark.

### Liability Financial Comparisons



**Data Exchange E-Reports** are electronic copies of Prime Reports. These reports are automatically emailed quarterly in PDF format. Data Exchange E-Reports can be ordered by mailing or faxing the Subscription Request Form to PERI. The form can be found in the Data Exchange section of the PERI Website at [www.riskinstitute.org/dataexchange](http://www.riskinstitute.org/dataexchange).

**Data Marts** are specialized reports designed to provide a dedicated user group with more detailed benchmarking data or information focused on specific loss areas. Data Marts are ideal for pools, brokers, insurers, reinsurers, and other organizations that want to compare their members or clients against a specific set of measurements.

**Mini Marts** are similar to Data Marts but for much smaller user groups – typically 5-10 users. Mini Marts allow a public entity to join with similar or neighboring jurisdictions to evaluate specific performance measures or analyze the claims environment in their region.

**Custom Reports** are defined sets of liability or workers' compensation reports that complement the free Prime Reports by providing greater detail for more in-depth benchmarking or adding comparative information customized to respond to specific questions.



**Standard Metrics for Risk Management** - This helpful list identifies standard metrics for both liability and workers' compensation data. The two-sided laminated sheet defines seven key metrics for liability and ten for workers' compensation. From Average Cost per Claim to Frequency Rate to Average Claim Duration, these metrics will help you evaluate the effectiveness of your risk management program. These metrics are also used in the Data Exchange, PERI's risk management benchmarking program.
