I am responsible for determining which items will be 50% off on Half Off Day, Sunday, September 29, 2019. I agree that I am consigning my items for the price listed on the bar code that I created and printed from JAN Consignment Sale, LLC website.
7. _____ I am responsible for determining if my items that were not sold will be donated or picked up by myself. I understand that I will receive a donation receipt for the items I donated along with my consignor check by October 9, 2019.
8. _____ I understand that I am responsible for the assembly of any item that requires assembly (large crib, toys, etc.) before it is placed on the sales floor.
9. _____ I agree that I will pick-up any items that were not purchased or donated on Sunday, September 29, 2019, from 5 pm to 7 pm. I understand that any items not picked up by 8 pm will become property of JAN Consignment Sale, LLC and donated in my honor to JAN Consignment Sale, LLC local charity.
10. _____ I understand that Seller checks will be mailed out by October 9, 2019. I understand that my check will be mailed to the address provided on this form and this is the same address I entered when registering as a Seller with JAN Consignment Sale, LLC website.
