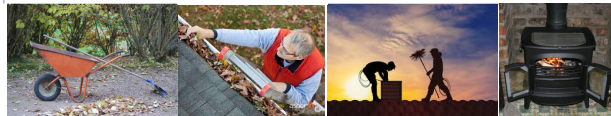

FY 2024/2025 Water **Base Rate Increase**

Water Base Rate	\$16.46 to \$17.29 = up	\$0.83
Water Improvement	\$22.73 to \$22.00 = down	\$0.73

The new rates, effective October 1, 2024, will be reflected on your November bill for October service.

Monthly Water Testing Results

Public utilities are required by law to take many expensive samples each month. They also must pay the employees that run them, as well as cover administrative costs.

The City of Cascade tests drinking water based on requirements specific to our permit. The testing locations are dictated by Idaho DEQ based on our water distribution system. Water testing occurs in areas with close proximity to our gravity fed tanks and end of the line locations.

New radio-read water meter installation will begin on September 20, 2024.



Public Works staff will locate and mark your existing meter and the contractor will be doing the meter change-out. This work will be performed throughout the month of October.

Your water service will be interrupted for 10-20 minutes while the installation occurs. Public Works staff will do their best to knock on your door and give you a heads up when they are ready to install at your home.

Installation for commercial locations will be performed prior to or after your business hours.
