2024 HOA Assessment Increase

Due to the increase in overall operating expenses, the monthly HOA dues are now \$143.85 per month effective

January 1, 2024. By now, you should have received a letter with the new dues assessment.

CdC Updates and Reminders

- Please do not park on the street overnight. On-street parking is not permitted unless both spaces in an owner's garage and both spaces on the driveway are occupied. CdC enforces this rule reasonably, recognizing owners have visitors and maintenance personnel from time to time. CdC will enforce the "no on-street parking" rule and issue fines when neighbors complain of repeated all-day or overnight street parking.
- Please pick up after your pet. It's a matter of common courtesy and it's the law.

- Trash collection is on Tuesdays and Thursdays. Please do not put out containers too early the night before and remove them as quickly as possible. They may not be stored in your front yard or on your driveway in front of your garage for extended periods. Failure to comply could result in a fine.
- You are responsible for the upkeep/maintenance of your backyard. If you have stagnant water, overgrown vegetation, or other recurring nuisances be aware that you can be reported to the city of Scottsdale EZ Services. EZ Services handles complaints and issues anywhere from street potholes, and property maintenance to short-term rental violations, etc. For more information go to https://eservices.scottsdaleaz.gov/ez.
