PRESIDENT'S REPORT *By President Joe Henschen* *Twitter @JaHe1*

With shorter daylight hours, and later start times, carriers are once again dealing with delivering mail after dark. This means you may wind up working in the dark. This causes issues every year. So, what is safe? "Safe" depends on you and your route. There is no blanket policy regarding delivery after dark, because the very core issue to contend with is whether a particular carrier on a particular route can safely make mail delivery. Bottom line: Each carrier must weigh individual circumstances about the type of delivery to be carried (door-to-door walking, mounted, apartments, cluster boxes, etc.), surroundings (unfamiliar, high crime, many steps and hills, etc.) and past experiences with after-dark deliveries.

Arbitrators have ruled that darkness in and of itself is not unsafe. Darkness can contribute to an unsafe situation. For example: You are on a walking route, it is not well lighted, and you trip over a crack in the sidewalk. A few feet later you stumble over something else. You may want to declare that loop as unsafe and move to the next task. As you deliver on the next loop, the same rule applies. If it is well lighted, then deliver the mail. If you stumble due to poor lighting, then stop. Move to the next loop. There are several things you can do to keep safe while delivering when it is dark. If you are on a walking route and it is not well lighted, then you don't cut across lawns. You want to walk where it is safest. This is normally the driveway and sidewalk. If the area is not well lighted, then you probably cannot finger the mail while walking since you may not be able to see the addresses well enough. Additionally, if it is

not well lighted, you cannot see where you are walking with your peripheral vision, so you actually need to watch where you walk.

You can have problems delivering on cluster box routes and dismount and mounted delivery due to darkness as well. If you have to turn on the overhead light to sort the mail for delivery, you may need to let your eyes adjust to the dark again before driving to the next box. Not allowing your eyes to adjust can result in a vehicle accident. For a cluster box, there may not be enough light to sort the mail at the box, and you may have to sort it at the truck and then head for the boxes to make the delivery. Dismount delivery is very similar to a walking route in the respect that you may not be able to sort the mail while you walk to the box. Management's plan requiring pivoting routes daily, may require you to be delivering in the dark on a route you are not familiar with. Everyone needs to case in the dog warning cards. It becomes more difficult to tell where the barking dog is when it is dark. You are the only one who can keep yourself safe.

If you choose to bring back the mail, let your manager know. You will need to be able to defend the decision with specific safety problems on the territory you brought back. Complete PS Form 1571 for all mail curtailed.

It is important to note it is not the intent of any carrier or of this office to endorse or encourage the unnecessary curtailment of any mail. It is about each carrier's safety and the protection of the mail in our charge and management's responsibility to manage. This is also not a blanket policy or approach. It very simply is the responsibility of each carrier to measure safety and report to supervisors any unsafe conditions encountered. It is management's responsibility to provide a safe environment, period.¹

I hope each of you have a safe holiday season and here's to hoping the Christmas season fills your home with the warmth and joyfulness that you and your family deserve.

Hubble's Troubles

to work with District Operations on a mutually agreed upon route adjustment process. The first adjustment was completed in Palmetto and resulted in one full route as well as a Carrier Technician (T-6) position.

The other adjustments were in the St Petersburg installation at Midtown and Gulfwinds stations. The outcome was the creation of six full routes, four at Midtown and two at Gulfwinds. In addition we will be looking at the T-6 strings that move between multiple offices to possibly realign so as to avoid the traveling from station to station.

The good, bad and indifference, were the PS Form 3999's (*Inspection of Letter Carrier Routes*). Using the most recent 3999's in DOIS to adjust the routes with the use of COR (*Carrier Optimal Routing*) proved troublesome with integrity of the data. The 3999's were full of errors and not accurate in many cases. Many were manually completed, basically pencil whipped. Sadly, many supervisors are not trained on completing a proper 3999, they're just giving the hand-held computer (*DCD*) and shown the start and stop buttons.

The basic principles in the study of the 3999, is to move one section of a route to another for the purpose of making adjustments. The street allied time is just as important as the actual delivery time. It includes load and unload time, travel to and from the route. Time spent collecting from blue boxes and pick-ups. It also includes the delivery of parcels and accountable mail as well as street breaks and comfort stops.

I urge all carriers to request a summary of the 3999. Compare the printout of the original Form 3999, the DOIS generated Form 3999 and Audit Trail Report which lists any changes made to the actual 3999. Make sure the 3999 is representative. If the supervisor won't provide those items in a reasonable time, then they either haven't entered it into DOIS or just hiding the fact they are not confident in what they were doing.

Just a brief *caveat*, edit books...they too are important. You can't get any time associated with new deliveries if the edit book is not up to date. Be sure to include new construction, business and residential, as soon as you come aware of the physical address and how many possible deliveries.

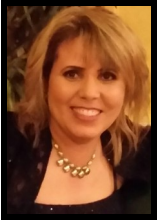

Greetings Branch 1477! This month's article goes out to those we all love so dearly, those we keep on speed dial, and those we thank so often for taking those last two loops, streets, or buildings. Yes, this Bud is for you CCAs. How many of you are thinking about your future? How many of you have a 30-year plan? A 30-year pace? How many of you have time to think? I'm writing to encourage you, "the future of our union", that the time is now to invest in and to secure your future.

A couple days ago, I opened my thrift savings (i.e. your investment opportunity when you become regular) to find that my investments have tripled since I became regular. Yes, there is light at the end of the tunnel. I began thinking, "How did this happen? Why? How could I have done more?" The answers to the first two questions were easy with a little reading and research. Common answers like the state of the economy, investing with a steady

fund, the effect of having a good job paired with the best union, etc. However, the answer to the third question was even easier.

I was a CCA for more than two years before gaining regular status. Upon making regular status and, like many, I put in the maximum I could afford. I thought to myself, "everyone does it, it is how the system is set up". Have you ever heard the saying, "There is no better time than now"? Let me share some findings:

"According to data compiled by the Social Security Administration:

- *A man reaching age 65 today can expect to live, on average, until age 84.3.*
- *A woman turning age 65 today can expect to live, on average, until age 86.6.*

And those are just averages. About one out of every four 65-year-olds today will live past age 90, and one out of 10 will live past age 95."

"Let's look at what happens when you invest \$10.00 per week at 8% beginning at age 30. At age 65 your initial investment of \$18,200 will have grown to \$99,402. That's \$81202 in earnings. Now, let's look at what your investment would be if you started 10 years earlier at age 20. Your initial investment of \$23,400 would have grown to \$228,563 at age 65 -- \$129,161 more in earnings."

The answer was simply this, I didn't put anything away prior to making regular. And the reason was...the days were long, the loops were too many, and I watched the sun set on my route too often, working seven to thirteen days straight, often getting home beat, tired, and just in time kiss my children good night...Plainly, there is no excuse.

Your union has a starter plan geared towards contributing to your retirement. Granted, you will not be a CCA for the next 30 years, but this plan will get you started. The NALC CCA Retirement Savings Plan administered by the Mutual Benefits Association offers a *tax-deferred* Traditional IRA (Individual Retirement Arrangement) and a *tax-free* Roth IRA. Those defined as follows:

"tax-deferred: In a Traditional IRA, the contributions you make each year can be deducted from your federal taxes. In addition, earnings accumulate tax-free until the time of withdrawal. Upon distribution at age 59½ or older, the earnings and principal are taxed as ordinary income.

tax-free: Contributions to a Roth Individual Retirement Account are not tax-deductible, but earnings accumulate tax-free. At the time of withdrawal, earnings are free from taxes if the owner has held the IRA for a minimum of five years and is at least 59½ years old.

These plans begin with as little as \$15 (\$1/day) per pay period (up to \$6500 per year depending on age) and can be deducted directly from payroll. Most importantly, when you become regular, you have the option to transfer all funds into your thrift savings. Consider it a boost; an extra opportunity to invest and grow your money early all for the cost of being a member to your union, the NALC. Stay safe 1477!

Going the extra mile...

Recently in the Seminole Post Office, some quick thinking and a little "Detective" work by Carrier Chrissie Curran saved a customer from mail and identity theft.

She was given a request for a Premium Forward. The request looked a little different from previous ones, but it came from the USPS website with a confirmation number. It was to be for a 2-month period and specified that the mail for the **entire household be forwarded.**

The problem was that she did not recognize the name of the individual. Rather than just accepting the order, she decided to go to the door and verify that they wanted their mail forwarded to Miami.

The customer was shocked and very grateful. They were not going to be away and did not want their mail forwarded! Obviously, thieves are even willing to lay out the money that a Premium Forward costs to be able to steal someone's identity.

Please be alert to this new method of thievery. This saved a customer from tremendous harm and grief.

As she does on an everyday basis, Chrissie went the extra mile to provide excellent Customer Service, treating her customer's mail as she would if it were her own.

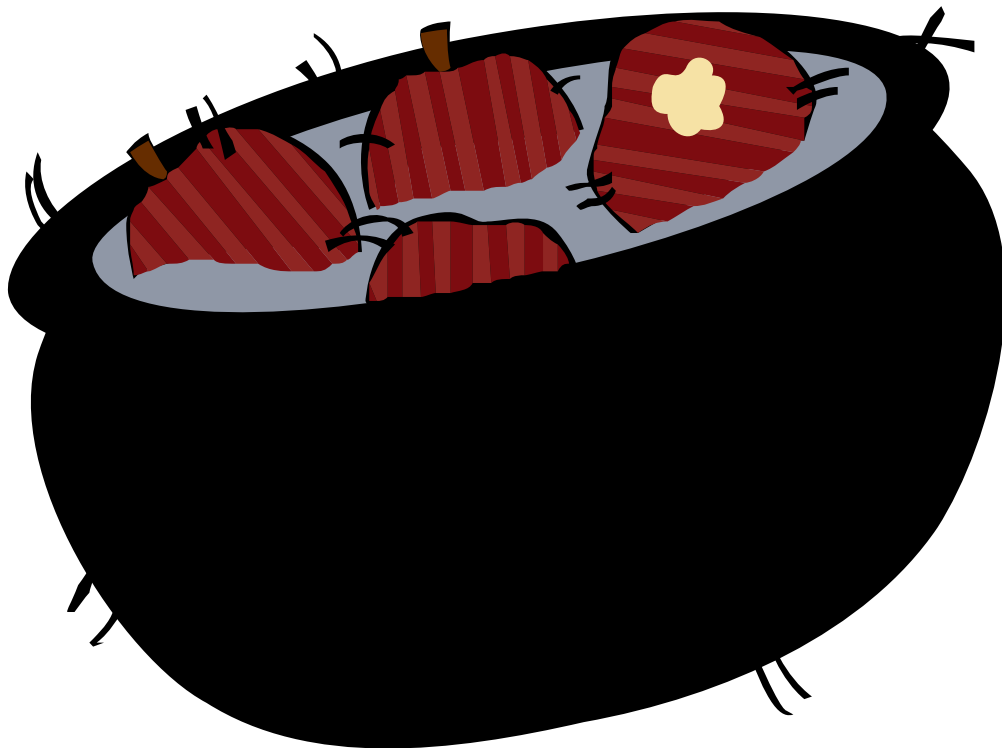
