

DELAWARE STATE FAIR CAMPING Rules and Regulations

I hereby request camping space at The Delaware State Fairgrounds Park. All campers agree to the following rules and regulations by signing below. No camping will be permitted without a signed contract.

- 1. Absolutely no subletting of space is permitted.
- 2. Camping is restricted to designated areas only.
- 3. No alcoholic beverages may leave the campsite.
- 4. Campfires must be contained in a fire pit/ring and be off the ground.
- 5. Please leave the grounds in the condition in which it was found.
- 6. Loud or abusive language and activities infringing upon the rights of others are strictly prohibited. Quiet time is from 11:00 PM to 7:00 AM. Quiet means no noise or activity that can be heard by your neighbor.
- 7. Pets must be leashed at all times. Owners are responsible for picking up and properly disposing of all pet waste in a trash receptacle. Loud/nuisance or aggressive pets are not permitted on the grounds.
- 8. No person under 18 years of age shall occupy a camping area unless accompanied by an adult. All children must have adult supervision. Parents and those persons bringing children are responsible for the safety and discipline of those children. Children are not permitted to play around/in restrooms or shower buildings.
- 9. The Fair does not have sewer hookups at camping sites. There are several dump stations available on the grounds for your use. Any sewage or wastewater (including gray water) discharge is illegal and subject to the laws and fines of the State of Delaware.
- 10. Trash or refuse is to be placed in centrally located litter containers.
- 11. Motorized or golf cart type vehicles may only be operated with prior approval by The Delaware State Fair, Inc.

 Operation is limited to event staff members. All operators must possess a valid driver's license.
- 12. A fire lane is to be maintained at all times.
- 13. FIREARMS, WEAPONS, EXPLOSIVES, FIREWORKS, METAL DETECTORS AND DRUGS ARE STRICTLY PROHIBITED.
- 14. Each camping patron agrees to hold The Delaware State Fair, Inc. harmless against any loss, cost, damage, theft, or other expense, including reasonable Attorney's fees incurred by it or any other person or persons by reason of the action of said camping patron while on the premises. The Delaware State Fair, Inc. will not in any way hold themselves responsible for accidents, loss, and damage by water, fire, theft or otherwise whatever may be the cause of extent of the damage or loss, whether caused by the conditions of the premises, the error or omission or negligence of any employee or agent of The Delaware State Fair, Inc. or otherwise.
- 15. Camping patrons who violate these regulations must leave the grounds immediately and forfeit all rental fees.
- 16. All decisions made by The Delaware State Fair, Inc., or its representatives are final.
- 17. All fees must be paid prior to or at the time of check in.
