# Pet Parade and Chili Cook-off 2019 Beneficiaries

### **CATMOSPHERE LAGUNA**

As the Orange County's first cat café, Catmosphere Laguna increases the county's rate of feline adoptions and provides improved lives and futures for kitties awaiting their *furr-ever* homes. Catmosphere Laguna's environment allows these homeless cats and kittens to safely transition into a home-like environment. 100% of the proceeds from adoptions go directly to the care, treatment, and welfare of our cats and kittens.

### **BLUE BELL FOUNDATION**

The Blue Bell Foundation for Cats offers loving and compassionate lifetime care for senior cats whose owners can no longer care for them. Their vision is to become the leading cat retirement sanctuary promising total peace of mind to cat owners with homelike, personalized care to the cats entrusted to us.

### LAGUNA BEACH ANIMAL SHELTER

A non-profit private facility sponsored by the City of Laguna Beach/Laguna Woods and through donations, has been operating for over 30 years. Sick, injured and stray animals rescued by animal control officers within the city limits are provided temporary shelter and any medical rehabilitation necessary to be put up for adoption. Funds will help to pay for extra medical needs of the shelter animals.

## PACIFIC MARINE MAMMAL CENTER

A non-profit organization, rescues sick and injured sea lions and seals along the Orange County Coast. Established in 1971, the center treats several hundred animals a year. Trained volunteers are on call 24 hours a day to rescue animals ranging from small pups to 500 pound adult sea lions. The Center also serves as an education center for children.

### **PUP (PROTECTING UNWANTED PETS)**

The fundraising arm of Laguna Beach Animal Shelter dedicated to bridging the gap between City funding and the special needs of our animals. PUP Laguna Beach directs fundraising efforts to ensure that the animals receive the best care possible including medical attention, neutering/spaying and behavioral reinforcement before they are adopted. In addition to fundraising, we are involved in animal issues that are brought to the attention of the City Council, along with working with the Police Department and Animal Control concerning any animal problems within our communities of Laguna Beach and Laguna Woods.

# 23rd Annual Chili Cook-Off Rules and Regulations

Enter your best chili recipe and bring your appetite. A panel of local judges will select "The Best Chili of the Year" from the entries. Proceeds from this fundraiser will go to

the Blue Bell Foundation for Cats, the Laguna Beach Animal Shelter, LBR/Charitable Assistance Fund, the Pacific Marine Mammal Center, and PUP (protecting unwanted pets).

## Laguna Beach Annual Chili Cook Off Official Rules and Regulations

- 1. True chili is defined as any kind of meat, or combination of meats, cooked with chili peppers, various spices and other ingredients. Veggie chili is also acceptable.
- 2. No ingredient may be pre-cooked in any way prior to the preparation period. The only exceptions are canned or bottled beans, tomatoes, tomato sauce, peppers, pepper sauce, beverages, broth and grinding and/or mixing of spices. Meat may be treated, pre-cut or ground. MEAT MAY NOT BE PRE-COOKED. All ingredients may be chopped, cut, sliced prior to event.
- 3. The cooking period will be a maximum of 3 hours. The exact starting and ending of the cooking period will be announced. Cooking during the entire period is at the sole discretion of the cook.
- 4. CHILI Contestants are responsible for supplying all of their own cooking utensils, etc., including stove. Butane stoves are recommended due to limited electrical outlets and power outages. Plastic spoons, sample cups, napkins and tablecloths will be provided.
- 5. CHILI and SNACK Cooks are permitted to set up their equipment, decorations and other facilities any time after 8:30 am the day of the cook off.
- 6. CHILI- Each contestant must cook a minimum of 8 gallons of chili. A sample will be collected at the end of the cooking period for the purpose of judging.
- 7. Each team will be given a container in which their chili will be collected at the time of the official judging.
- 8. CHILI, SNACK and ACTIVITY- Cooking/Activity teams may not contain more than three (3) team members. Any additional team members must pay the \$10 entrance fee.
- 9. There will be an award for Best Chili and the Best Decorated Booth.

- 10. The decisions of the Judges will be final.
- 11. Judging will begin at approximately noon.
- 12. DECORATIONS: only tape or string can be used to affix your signs, posters, etc., to the walls.
- 13. SNACK BOOTH: You will have an option (one only) to serve hot dogs, popcorn, lemonade, water/soft drinks, or ice cream. You will have to provide enough for 150 guests.
  - a. You are responsible for supplying all of your own cooking utensils, etc., including stove. Butane stoves are recommended due to limited electrical outlets and power outages. Napkins and tablecloths will be provided.
  - b. Popcorn machine will be provided. It must be returned to LBR/CAF in the same condition received by 10/10.18. We also require \$100 deposit for machine use.
- 14. ACTIVITY BOOTH: You will have an option (one only) to select a balloon artist, fake tattoo artist, airbrush face painter, or caricature artist.
  - a. LBR/CAF will provide the artist for a maximum of 2 hours. Any extra hours must be provided by sponsor.
  - b. Tattoo artist booth will have to provide their own team members to run the booth and fake tattoos.

# seven7seven Rules & Regs

Thank you for participating in the Pet Parade & Chili Cook Off. Please reference below for the use of seven7seven grounds and their workers. Please note that nothing on the grounds can be moved, adhered to with nails or tacks and/or changed in any way. Any and all posters and/or decorations need to be erected in some other way to have them stand alone. Decorations could be taped or strung with wire or fishing line in the booths or from umbrellas if needed.

Contestants should be self-sufficient, i.e. cooking supplies, cooktops, utensils, etc. seven7seven will not provide any cooking supplies, utensils, miscellaneous items or man-power. seven7seven has a history of their circuit breakers blowing fuses or power surges, therefore, please limit the amount of extension cords and plug-ins for everyone's convenience the day of the event.

Please note that the placement of the Chili Booths will be at the discretion of the organizers.
