DIRECTIONS TO EVENT SITE

From Rt. 95 North and South - Exit 6B to 495 North to exit 15 (Rt 1A). Take right at end of ramp.

Follow Route 1A North for 3 miles; stay on Rt. 1A; go past the intersection on Rt. 140. Take a left at the blinking yellow light (North St.). Left on Emerald St. and follow the signs.

From West - 90 East to 495S to exit 15. Take a left at the end of the ramp, follow directions above.

Motels and Hotels are difficult to find. Consequently, the Event Committee will take any necessary action against any individuals whose rooms have been damaged. We will check with all hotels as to room conditions.

RULES

- 1. The "Regulations for Lure Coursing Tests and Trials," including "Regulations for Fast CAT (Chapter XVI)," will govern these events. These regulations may be accessed at www.akc.org.
- 2. Bitches known to be in season are not permitted at the event site.
- 3. Each dog runs at its owner's sole risk.
- 4. Handlers must check in with the inspection committee about one hour before the dog's first run to receive a briefing and to have the dog inspected.
- 5. Inspection shall take place prior to any form of wrapping being applied to the dog.
- 6. In the opinion of the inspection committee, any entry found to be lame, unfit to compete, or a female in season shall not be allowed to participate, and entry fees shall be refunded in full.
- 7. If necessary, the inspection committee is responsible for measuring dogs to determine their height at the withers.
- 8. Handlers and their dogs must be present and in line at the scheduled run time.
- 9. Dogs may wear any type of collar except choker collars, a collar with prongs, or an electronic training collar. Any tags hanging from the collar must be taped up.
- 10. Owners may have their dog wear a muzzle if they desire.
- 11. Owners may use clips or rubber bands to hold the dog's hair.
- 12. The owner assumes responsibility for the safety of the dog with regard to the dog's collar and paraphernalia on the dog.
- 13. Head halters, such as the Gentle Leader or Halti, may be used on the grounds but must not be worn while running the course.

- 14. Each dog must have a handler at the start line and a catcher to retrieve the dog in the catch area. A handler cannot recall their dog from the start line.
- 15. Handlers are not permitted to travel down the 100-yard course during a dog's run or just prior to a dog being released for its run.
- 16. Handlers are not to allow dogs to be enticed through the course with anything other than the lure during its official run. However, cheering and using the dog's name are allowed.
- 17. If a dog fails to run at any point during the run, the huntmaster will instruct the handler to retrieve the dog, and the run will be considered incomplete. No time for that run will be recorded. Incomplete runs will NOT be rerun. However, AT THE DISCRETION OF THE HUNTMASTER, the dog may return to the starting line immediately for a practice run if the handler desires.
- 18. All dogs must be on a lead or crated, except when running official runs.
- 19. Owners/handlers must pick up after their dogs and deposit all trash in the trash cans.
- 20. The Test Committee is responsible for compliance with all regulations and has the authority to decide upon all matters arising during the running of the event.
- 21. The Test Committee may decline any entry or remove any dog from the event grounds for cause.

NOTICES

- 1. Owners/handlers should bring ample water and provide shade for their dogs.
- 2. Dogs should be walked for about 5 minutes both before and after they run to reduce the risk of injury.
- 3. The two events will be run CONCURRENTLY. Dogs will be organized in groups, or "heats" (six groups of 12 dogs each). The FastCAT committee will choose the dog's group upon receipt of entry form with payment. One group will run each hour. Each dog entered in both events will run two times during that hour. The first run will count for the first event, and the second run for the second event. Entering only one of the events is an option.
- 4. A continuous-loop lure system and an electronic break-the-beam timer will be used. In the event the timer is not functioning, two stopwatches will be used.
- 5. The track will be completely enclosed by temporary fencing.
- 6. The runout after the finish line is 60 yards long.

- 7. A portable restroom will be available at the site.
- 8. The event will proceed "rain or shine," unless the Test Committee determines that the weather poses a danger to people or dogs. THE TEST COMMITTEE HAS THE RIGHT TO CANCEL THE EVENT WITHOUT NOTICE DUE TO INCLEMENT WEATHER OR UNSAFE FIELD CONDITIONS.
- 9. New England Rhodesian Ridgeback Club, its agents, members, representatives, and volunteers assume no liability or responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

AWARDS

- A participation ribbon to each dog that completes the 100-yard dash
- A new-title ribbon to each dog that finishes a Fast CAT title at the event, while supplies last

ELIGIBILITY TO ENTER

- The dog must be at least 12 months of age to enter.
- The dog must meet one of the following requirements to enter:
 - Individually registered with the AKC
 - Recorded in the Foundation Stock Service (FSS) program
- Individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration
 - Granted a Purebred Alternative Listing (PAL) number
 - AKC Limited or Conditional Registration
 - Enrolled in the AKC Canine Partners Program (if the dog meets none of the above requirements)
 - To enroll in Canine Partners, go to www.akc.org/register/information/canine-partners/enroll

HOW TO ENTER

Your entry must include an EMAIL address to receive information about run times.

The entry fee per event is \$30. Payment by check must be included with your mailed registration or can be made via Zelle (see below). No payments will be accepted on show site. Your registration will not be processed if payment is not received in advance.

Information provided on the entry form must be that which applies to the entered dog. Entries MUST include an EMAIL address to receive information about run times. One entry per dog.
