a. Inhelder with MSA presented the preliminary design and cost to the City for the Pioneer Pavement and Drainage Improvement Project. The estimated cost of the project is \$122,000. Fouts moved and was seconded by Bartello for Inhelder to send bids out as soon as finance is secured. Motion carried 5-0. Machin will contact Spear Financial to begin the financing process. Inhelder also presented the Council with a timeline for the project with work estimated to begin in June.
