249 The Miranda v Arizona 384 U.S. 436 (1966) decision of the Supreme Court came  
250 only after decades of abuse by American police against citizens, not unlike what we

251 are watching today. The Miranda decision is hated by police, prosecutors, right-wing  
252 judges, politicians, and citizens. The decision is based upon the history of the right not  
253 to be coerced that began with the famous trial of John Lilburn before the English  
254 court of the Star Chamber in 1637 where he stood tall and objected to the King's  
255 torture. Lilburn's crime was handing out pamphlets against the king. John Lilburne  
256 (1615–1657) was a leader in the Leveller Movement of the 1640s and was a prolific

363 That Court also stated that Section 455(a) "requires a judge to recuse himself in any  
364 proceeding in which her impartiality might reasonably be questioned." Taylor v.  
365 O'Grady, 888 F.2d 1189 (7th Cir. 1989). In Pfizer Inc. v. Lord, 456 F.2d 532 (8th Cir.  
366 1972), the Court stated that "It is important that the litigant not only actually receive
