Supervisor: Kangas is waiting for a response from the health insurance carrier concerning the renewal of the policy. A citizen was inquiring about some land he would like to purchase that the Township owns. Kangas explained that it cannot be sold as it is under the Wellhead Protection Plan in the Township. Kangas and Simmons had a meeting with the Gogebic County Road Commission- they are asking for a list of road repairs for 2022, they will have matching funds available. The Township hasn't heard back from the Dept. of Treasury concerning our audit, so it is assumed it is acceptable. John Garske agreed to update the Township's Parks and Recreation Plan. Kangas was in contact with the DNR concerning the Township owned property for motorized vehicle use.

Treasurer: The Township wide Fall Cleanup was successful- with 26.6 tons of garbage being brought by Township citizens.
