2. Annual Fee: includes Summer Camps & Spring Training held @ Ballard.
3. Annual Fee: does not include athletic shoes, travel suits, food & other misc. items.
4. Concession and Gate: Each Family is required to work concession and gate. This includes Clean up after the home games. Working Concession & Gate are considered part of your Athletic Fee, However if you are unable to work C & G, You can pay an extra \$ 100 AF & be exempt.
5. Athletic Fee Assistance: Families can sell (2) Signs on Football Fence to pay for (1) ath fee.
