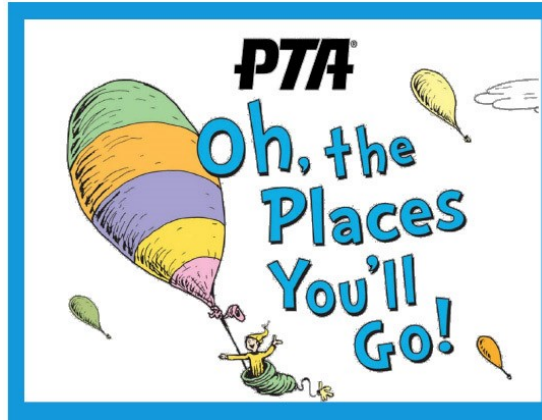

### REGION BYLAWS

The following proposed amendments to the region bylaws will be voted on:

Article XIII Region Meetings

#### CURRENT

Section 1 c.- Each unit shall be entitled to be represented at the annual meeting by its president or alternate and one (1) delegate for each fifty (50) members or a major fraction thereof.

#### PROPOSED

Section 1 c.- Each unit shall be entitled to be represented at the annual meeting by its president or alternate and one (1) delegate for each **twenty-five (25)** members or a major fraction thereof.

#### AND

#### CURRENT

Section 1 f.- Thirty (30) delegates, representing 25 % of the member units and councils, shall constitute a quorum.

#### PROPOSED

Section 1 f.- **Twenty-five (25)** delegates, representing **20 %** of the member units and councils, shall constitute a quorum.
