The 'ECONOMIC-Concept' endeavors' to turn people from being elitist polluting selfish parasites (*capitalists*) & incompetent technocrats (*communists*) a threat to other people & 'Planet Earth'. Into a 'Custodian' of the creations of 1GOD!

CONCEPT 1

CROn (Community Run Owned not-for-profit) replace capitalism (greedy, profiteering, private-owner parasites), communism (incompetent technocrats) & hybrids (half parasite/half incompetent).

Private-ownership entity is confiscated without compensation & is converted to operate as a 'CROn'.

State-owned entity is converted to operate as a 'CROn'.

'Shire' sets up a 'CROn'.

'C' community is a 'Shire'

'R' run by '**D-mC**' (Decision-making Committee of 7)

'O' owned by its workers paid wmw & unpaid volunteers

'n' not-for-profit



CROn organization needs to be managed. Single leadership is tyranny. Leadership by Committee is fair. **CROn D-mC** use business performance Indicators & feedback from all stake-holder for decision-making.

'D-mC' (Decision-making Committee elected for 1 year) consists of 7 members: Coordinator, Treasurer, Go-for, 4Trustee. A CROn D-mC needs to use **bpI** (business performance Indicators), **Jic** (Just-in-case), **Es** (Economies of scale).

ZERO TOLERANCE to private-owner parasites & incompetent technocrats !!!

CONCEPT 2

All land & dwellings are local-community *(Shire)* owned. CROn, Provincial-Government & families lease from the Shire. Everyone is a tenant.

Freehold land is transferred without compensation to the Shire.

Owner Occupier can stay in house until they want to move or die. Then Shire takes control without compensation (there is no estate for property).

Freehold land is private ownership land. Depriving community use of land for benefit of all. Freehold (*No Trespass*) denies usage of all beaches, of lake & river frontages, denies picnicking on golf course,...

1GOD created Planet Earth to be used & enjoyed equally by all People. Freehold land & privately owned dwellings are insulting to **1GOD**.

Freehold land is used by investors to speculate (gamble) hoping to drive up property prices (profiteering, capital gain) denying the community affordable shelter. Investors also use freehold land for criminal tax-avoidance (negative-gearing).



Some investors erect flimsy buildings & charge overpriced rent. People who can't pay become homeless. Investment Property is not really bought for rental income but used as tax-evasion. Resulting in decaying buildings. The emergence of slums unsuitable for human habitation(*rodents love slums*).

ZERO TOLERANCE to FREEHOLD!!!

CONCEPT 3

Every adult has a right (*duty*) to rewarded work. Rewarded work entails getting a wage & conditions. For best economic management everyone's a wage earner.

For economic management, wages & conditions (wmw) are set by Provincial Government. wmw are set annually. wmw may stay the same, or go up, or go down as economic conditions require. Note! Private ownership, State ownership are abolished & replaced by CROn. Unions are deregistered. Government sets wages & conditions.



There are 7 pay grades. Pay is based on a 'weekly minimum wage' (wmw) & a multiplier. Pay-scale starts with a wmw x1(minimum) to wmw x7(maximum) reward range: wmw x1 unskilled, apprentice ~ wmw x2 skilled, Tradesman ~ wmw x3 Senior-Tradesman ~ wmw x4 Supervisor ~ wmw x5 Leader ~ wmw x6 Manager ~ wmw x7 (maximum) administrator

Conditions for all 7 pay grades: Expecting SHE's receive 7 weeks paternity leave at wmw x1 then **SmeC** rules apply ~ HE's receive 1 week maternity leave at wmw x1 ~ Sick-pay for all pay-grades is wmw x1 ~ There is 3 day grievance leave at wmw x1 ~ There are 2 weeks (14 days) annual-leave pay-grade is wmw x1 ~ There is no annual-leave loading, nor long-service leave ~ Work gear, Food, Drink & hygiene are provided.

Pay grades have minimum qualifications: wmw x1 (no skills), wmw x2 (completed 'CE' service, skilled or 'Trade Certificate'), wmw x3 (work experience), wmw x4 ('Supervisor-Certificate', CE reservist), wmw x5 ('Leader-Diploma', CE reservist),

wmw x6 ('Manager-Dip loma', CE reservist), wmw x7 ('Administrator-Degree', CE reser-vist). Career path! When there is an opening,

promoted by seniority. Further study after qualifying (HE & SHE).

Workers who cannot find full or part-time work. Are usefully employed by the 'Shire' on wmw x1. Eliminates unemployed!

SUPPORT wmw!!!

CONCEPT 4

All Intellectual-property (copyright, patent,...) belongs to the community (Shire). Free to use by all. Profiteering from Intellectual-property (patent, copyright,...) is a crime: MS/R6

The Shire & Province provide 'Free Education' from cradle to cremation. In return all Intellectual-property belongs to all members of the community. Passing on Intellectual-property to foreigners (multinationals, spies...) is Treason: MS/R7

Free Education is provided by Shire (*SmeC*) & Province (*PHeC*, *PDEc*, *CE*). Everyone is learning & teaching all live long. Individuals provide 'Knowledge -continuity'.

SmeC 'Shire medical & education Complex'. The Shire provides free medi- cal from conception to death & free education to children & seniors. It provi- des these community-services via 'SmeC. The SmeC also is a careerpath for only SHE!



PHeC 'Provincial Hospital & education Complex'. The Province provides free Hospital from conception to death & free education to young HE & adult HE & SHE.

PDEc 'Provincial Defense & Emergency center'. 'PDEc' gives assistan -ce, guidance & protection in an emergency to the Province & its' Communities (*Shires*). PDEc initiates 'Holy-Matrimony Contract', train Administrators via 'Leadership-camp'.

CE 'Community Emergency service'. Every 17 year old SHE & 18 year old HE has to attend 1 year compulsive 'CE' service. The 'CE' assesses each youth (includes handicapped) for their usefulness to the community & decides how their usefulness may be enhanced. CE removes parenting influence & replaces it with 'Communities Duties & Rights'. CE decides career-path of each HE & SHE as per their abilities & community needs.

Free Education provides a career path beginning with an Apprenticeship as promoted further study is available. Elitist useless shortcut Education (*Universities*) is a waste. Graduates are employed as no skilled workers wmw x1 If they seek a career they have to start an Apprenticeship. Universities are 'Shut'! Non-Government education is 'Shut'!

An individual's life-experience knowledge (intellectual-property) is to become immortal it is to be preserved. The Knowledge-Continuity approach identifies critical knowledge

& provides methods for capturing, transferring & applying that knowledge. Life-experience knowledge needs to be separated between work & personal.

When an employee leaves vast amounts of intellectual-property are at risk. To counteract this brain-drain it is critical that the employee's intellectual-property is preserved. It becomes essential to capture & preserve this knowledge before the employee leaves. Capturing means audio(story-telling), video(showing), shadowing(work alongside).

A Individual's life-experience knowledge(intellectual-property) is shared with the community & family. Community-sharing comes via the Free Education system. Sharing means oral, audio(story-telling) video(showing) shadowing(hands on).

Family-sharing comes via children & grandchildren. Sharing means oral, audio(story-telling), video(showing), shadowing (hands on). Every individual from age 14 is to record their life-experiences (both positive & unsettling).

CONCEPT 5

Gambling is an addictive **bad** commercial or personal economics **concept**.

Commercial gambling includes, land & real estate speculation(capital gain), Derivatives(bonds, forwards, futures, hedges, leverages, options, shares, stocks, swaps, warrants,...) Funds. Freehold ends. Gambling venues (casinos, exchanges, lotteries,...) are closed. Gambling promoters & profiteers (bookies, funds-manager, futures-traders, stockbrokers,...) get, MS/R7

Personal gambling includes, betting (cock-fights, dog-fights, horse-racing Sport-betting underground-fights, 2up, other outcomes, ...) & playing (bingo, games, lotteries, internet, poker,...). Gambling venues (bookies back -rooms, betting-shops, casinos, Internet websites, lottery outlets,...) close. Gambling promoters & profiteers (bingo, bookies, lotteries, Sport-betting, Internet websites, any other betting &/or gambling, ...) get, MS/R7



Gambling is an addiction. Addiction is repetitive compulsive behavior gratifying a perceived need. Addicts *(junkies)* delude themselves*(foolish)* by not accepting the harm their behavior is doing. Harm to them selves

family, friends, work-mates & community.

Addicts do not believe they are addicted as long as they are enjoying themselves & holding their lives together. Addicts are ignorant(*stupid*), gullible & weak(*pathetic*)! Once addicted they become a threat to themselves & community. They become delusional, immoral, dishonest,

deceitful, selfish, uncaring & anti-social. This forces the community to control their life-style. Limiting freedoms & rights.

ZERO TOLERANCE to GAMBLING!!!

CONCEPT 6

Commercial & Personal Credit is predatory lending (*Loan-Shark operation*) it ends. Credit enslaves the Debtor which is cause & effect of Debt-collectors. Predatory lenders & Debt-collectors are criminals, **MS/R6**



Government(*Provincial*, *Shire*) cannot use credit to finance their budget. Government revenue(*Taxes & Fines*) goes up government services increase (*wmw goes up*) government revenue decreases its service s are cut back (*wmw goes down*). Government doesn't use credit & stops commercial & personal credit.

Commercial credit a hangover of Capitalism ends. CROn are set up by Shire. CROn have to survive on revenue they generate. If they continue to not break-even they close down.

Commercial, personal credit stops. Repayment of loans between friends, families.... cannot be enforced. Debt-collectors are criminals, **MS/R6**

Say 'No' to Credit/Loans & punish Debt-Collectors

CONCEPT 7

Taxes are needed so Government may fulfill its obligation & expectations to its people. Tax-minimization & tax-deductibility end. They are tax-avoidance a crime: **MS/R6** Tax-Shelter are closed.

Tax-shelter: Alaska, Andorra, Bahamas, Belize, Bermuda, Cayman, City of London, Curacao, Cyprus, Delaware, Dubai, Florida, Jersey, Guernsey, Hong Kong, Ireland, Isle of Man, Liechtenstein, Luxembourg, Monaco, Nevada, Panama, San Marino, Singapore, Seychelles, South Dakota, Switzerland, Texas, Turks & Caicos, Vanuatu, Vatican, Virgin Islands, Wyoming.

Tax-minimization is Tax-avoidance! **Trusts** are Tax-avoidance! **Tax-deductible Donations** are Tax-avoidance! Tax-avoidance is stealing from the Community! Tax-avoidance is a Crime: **MS/R6**



Custodian Guardian support the need of Government to collect taxes. C-G oppose Tax-avoidance. Paying Taxes an enforcable Civil Duty!

Rewarded work entails getting a wage & conditions. Pay is based on a 'weekly minimum wage'(wmw) & a multiplier. The weekly minimum wage (wmw) is set every year by Government.

Note! 'VAT' is collected by the 'Shire'. The Shire keeps 50% of the tax collected & forwards 50% to the Provincial-Government. Provincial Government collects & keeps all other Taxes. Furthermore both Shires & Province raise money through, charges, fees & fines.

¹Universe Custodian Guardians do not support private enterprise. They do support "CROn" (Community Run & Operated not-for-profit).

Unearned is something gained not by merit, labor or service. Unearned income, position, power & wealth end.

A Deceased person has a community afterlife: Estate, Knowledge-Continuity, Heritage & Traditions. Estate passes on accumulated knowledge & life-experiences, heritage, family traditions & memorabilia. Estate does not pass on Position (ends with death), Power (ends with death), all Wealth goes into Government Revenue.

Charity that have Tax-deductible donation status are **fake**! They are tax-avoidance schemes endorsed by corrupt Government. Don't donate to these! Close down Charity & confiscate assets. Prosecute Government, **MS/R6**

C-G Economic's for a fairer Community! That lives useful rewarding lives!

Mandatory Sentencing Justice is mandatory Sentencing accumulative, non-consecutive.

Rehabilitation Rehab involves education, asset seizures & caging.



MS (*Mandatory Sentencing*) brings consistency of Sentencing & the appearance of equality. Prevents corrupt & incompetent Officer of the Court interfering with Sentencing. MS does not allow corrupt, unjust 'Discount Sen-tencing'.

You do the CRIME >>> You do the TIME

Serial Criminal should not be rewarded. Multi-Guilty finds Criminal should not be rewarded by consecutive serving of Sentences.

Accumulative Sentencing is needed for repeat 'Offenders'. Repeat Offenders have not learned from their previous Rehabilitation & therefore need to re-do the Rehabilitation. Past & Present Sentencing are combined, given a total Rehabilitation time.

Death-Penalty (*Execution*) as Punishment is Anti-1**GOD**, unacceptable. Any Government that Executes is Criminal & is removed, prosecuted. **MS/R7**

Rehabilitation(*Rehab*) involves education, asset seizures & caging. Rehab punishes the Guilty & protects the Community! It helps Guilty.

The Guilty is explained his wrong-doing, taught to apologize, how to make amends & become a useful member of the Community. No more disgracing the family, rehabilitate & help other misguided Souls to do the same!

Rehabilitation has 7 grades **R 1-7**. Their are 2 types of Rehabilitation, Shire & Provincial. Which of the 2 apply depends on age & MS-R grade. There are 3 age groups, Teenage (8-14), Juvenile (14-17 SHE/14-18 HE) & Adult (SHE 17+, HE 18+) Children under 8 years are not prosecuted. Parents & educators deal with them. *Pleading Guilty (confession+all details of wrongs)
