General Meeting Minutes

December 10, 2020

Board Attendees: Tony McClure, Don Spearing, Cal Roberts, Daisy Spearing, Vic Gurinowitsch, Dan Charles, Alan Gerard, Traci Gerard, Mike Wyckoff & Tom Yost.

Secretary's Report: Daisy Spearing read the minutes from the November 12, 2020 meeting and a motion was passed approving it.

Treasurer's Report: Cal Roberts read the treasurer's report including a savings balance of \$38,357.14 and checking \$23,951.12 and a motion was passed approving it. Daisy Spearing asked when a transfer to bring the checking back down to \$10,000.00 will be completed. Cal responded that with the virus he is not making any unnecessary trips so he will do it at the end of next week when he makes a deposit. Daisy asked if he was disregarding a motion that was made by the board of directors this Monday until the end of next week and Cal responded yes.

Membership Report: Mike Wyckoff provided a membership report: 9 Board of Directors, 20 Voting Members and 242 Social Members and for a total of 271. 33 Life Members, 3 Honorary and 8 Jr. for a total of 315. Mike clarified that 2 Life Members were added to the total that were missed before.

Mike had 6 applications for new members: Joseph R. Grandinetti, Anissa J. Curenton, John Delich, Earl J. Reynolds, Jason Liberatore and Robert (Bobby) Williams. The applicants whom were present introduced themselves. There were no objections to accepting these new members.

Small Bore: Mike Sabot stated they are still shooting individually due to the virus and sending in their scores. He anticipates it will remain this way the whole season. They are always looking for new members to join the team.

Jr. Shoot: Dan Charles reported that the first Saturday they had 17 kids and it was a great time with the kids shooting straight and safely. The next Saturday there were not as many but they always have new kids coming.

Pistol: Tony McClure announced that we are still working on scheduling Ladies Night and Men's Night and are considering alternating weekly between the two events.

County League: Vic reported that the County League has changed their focus to provide additional support for the 2nd amendment by strongly endorsing legislation the defends the 2nd amendment.

Communications: None.

Bills: Cal stated he had 2 bills submitted, one from W.F. O'Brian that you know about already and one from Dan Charles for \$113.00. A motion was made and passed to pay these bills.

Unfinished Business: Dan Charles spoke on the following:

- The BOD voted on who will be foresting the property and went with Detweiler Wood Products from Knox, PA. They will pay the whole amount, either in two payments or all at once, before they start in Jan and will take around 6-8 weeks depending on the weather. Initially we were talking about \$100,000.00 but that did not take into consideration the steep terrain at the club and cost of removal. The accepted bid was \$56,262.00, the Forester will get 10% of that, so the Club will clear \$51,662.80.
- There is going to be a delay in starting the Archery Program due to the virus because the kids cannot shoot with masks on. The bows and arrows are ready, the heaters are here and need installed but we may have to start at a later date.

New Business: Tony McClure updated on the following:

- Make sure you check the Club calendar because there are training events scheduled.
- We are going to get a RSO class and an NRA Pistol Certification scheduled. We need the additional help for our events.
- A Legal Seminar will be scheduled concerning the Castle Doctrine and Stand Your Ground.
- We also plan to schedule a First Aid/AED/CPR class.
- Dan Charles reported that the excavating was completed for the pavilion so it can settle over the winter before the concrete pad is poured. They cut a road back to the location.

Remarks:

- Vic Gurinowitsch stated that he has read about ways to mitigate the virus and one was that a combination of Vitamin D3, Magnesium, Zinc and K2 seemed very promising.
- Mike Wyckoff reported that the renewal is going very well, he has around 25 outstanding members and 5 that will not to renew due to moving or health issues. Don Spearing inquired if those 25 were still included in the total count and Mike answered that they are.
- Mike Sabot asked what the status of dredging the pond was. Dan Charles replied that the fishing derby went so well with the kids catching a lot of fish so he sees not need to dredge. The pond was cleaned out one work day and treated.
