Rules and Regulations

1. This is a St. Joseph MO USBC Sanctioned Event.
2. All entry fees must accompany the entry blank. Entries turned in without the entry fee and incomplete entries will be returned.
3. **The ten-pin rule is NOT in effect for this tournament.**
4. **USBC Rule 319c does apply.**
5. **USBC Rule 327b.** After a score has been recorded, it cannot be changed except if there is an obvious error in scoring or calculation. Obvious errors must be corrected by a tournament official immediately upon discovery. Tournament management shall decide questionable errors. All protests must be in writing to tournament management before completion of the current event, otherwise scores will be correct as entered.
6. Team captain is responsible for an eligible lineup; scores will not be allowed for any violations.
7. Team lineup **MUST** appear on the entry form in the proper order so that the score sheets can be prepared in advance.
8. Teams or individuals failing to appear at their scheduled time to bowl may start in their regular turn, coinciding with the rest of the squad, at the discretion of the Tournament Management. Those who do not show, forfeit their place and entry fees.
9. **All bowlers must check in 1/2 hour before their squad time and present their USBC card.** Squads may be started ahead of schedule if all bowlers are present.
10. Any entrant appearing at his/her scheduled time of bowling who appears to be under the influence of intoxicating liquors or any entrant who willfully delays the normal progress of the game, an entrant whose conduct or attire on the lanes is considered objectionable to tournament management, may be removed from the lanes and tournament, regardless of whether a qualified substitute is available or not. **NO TANK TOPS OR OBSCENITIES ON ATTIRE. NO CUTOFF JEANS ARE ALLOWED.**
11. In the event of mechanical failure it is hereby agreed that the bowlers affected shall be moved to the next available lanes in the establishment at the discretion of the Tournament Management.
12. **USBC Rule 11:** – Forfeit - Delay of Game. No unreasonable delay in the progress of any game is permitted. If a player or team in a league or tournament refuses to proceed with a game after being directed to do so by a league or tournament official, the game or series shall be declared forfeited.
13. **USBC Rule 12:** The application of any foreign substance on any part of the approach that detracts from the possibility of other players having normal conditions is prohibited. This includes, but is not limited to, such substances as talcum powder. Pumice and resin on shoes; also soft rubber soles or heels that rub off on the approach.
14. **USBC Rule 18:** Altering the surface of the bowling ball by use of any foreign substance while bowling is prohibited. All bowling balls so altered must be removed from the competition. No foreign substances allowed in the bowling area.
15. Each individual bowler is held responsible for rule violations and is subject to USBC rules and regulations governing Tournament Competition.
16. The Tournament Manager reserves the right to check any bowling ball used in tournament.
17. We reserve the right to move entries if squads cannot be filled.
18. Tournament management reserves the right to make any changes to the tournament up to the start of the tournament.
19. Prize fund to be paid within 30 days of the conclusion of the tournament. Checks are void after 90 days.

Tournament Specific Rules and Format

20. Tournament is open to men 50 years of age and older, on or before January 14th 2018. Entrants must be a member of St. Joseph MO USBC.
21. Bowlers may enter singles and doubles once. Bowlers must enter both events. Entry fee must accompany this entry form. Entry form must be filled out completely, as well as the bowler ID number (Found on your USBC card).
22. Handicap is 80% of 220 going off of last year's book average. If any individual does not have a current sanctioned average he may enter on a scratch basis.
23. Each event is bowled on one pair of lanes. After finishing Singles, you start Doubles. You will bowl on the same pair of lanes. Substitutions may be made for both Singles and Doubles.
24. Prize fee is 100% to prize fund.
25. Shadow balls will be given before Singles event only.
26. There will be two (2) Singles Divisions.
 - a. Class "A" (61 years and older)
 - b. Class "B" (50 years thru 60 years).
27. Doubles will have two (2) Divisions.
 - a. Class "A" (combined ages of 121 and up)
 - b. Class "B" (Combined ages of 100-120). Age of the bowler must be shown on the other side.
28. USBC rule 309 requires that within 30 days after the tournament ends, the Tournament Directors distribute all awards and file a financial report statement with the USBC office.
29. Bowlers need not be a member of a "Senior League".
