OFFICIAL MINUTES OF THE REGULAR MEETING OF THE BOARD OF WESTON COUNTY COMMISSIONERS, WESTON COUNTY, WYOMING

March 5, 2024

The regular meeting of the Weston County Board of Commissioners was called to order by Chairman Don Taylor at 9:00 a.m. at the Weston County Courthouse. Commissioners Ed Wagoner, Nathan Todd, Garrett Borton and Vera Huber, Attorney Michael Stulken and Clerk Becky Hadlock were present. Waver Springs opened the meeting with prayer, and Vice-Chairman Borton led the Pledge of Allegiance.

APPROVAL OF AGENDA

Commissioner Wagoner asked to pull the Weston County Solid Waste District Board Appointment from the Consent Agenda. Vice-Chairman Borton moved to approve the agenda as amended, seconded by Commissioner Wagoner. Carried.

Community Prevention Specialist Kristi Lapp discussed with the Board the proposal she had presented for the Gambling Funds. Vice-Chairman Borton moved to award these monies for gambling addiction to Bob Bonnar and his team for his proposal, seconded by Commissioner Huber. Discussion ensued. PUBLIC HEALTH

Weston County Nurse Manager Angela Phillips came before the Board for a budget adjustment. Commissioner Wagoner moved to adjust the Public Health budget by \$18,800 out of financial admin, seconded by Vice-Chairman Borton. Carried.

FAIRGROUNDS UPDATE

Mr. Kline would like to move \$6,000 out of the salaries account and put \$3,000 into maintenance and \$3,000 in admin. Commissioner Wagoner moved to move \$7,500 into maintenance for minor repairs, seconded by Vice-Chairman Borton. Carried.
