COMPLAINT FOR DIVORCE
Comes now the Complainant, Holly Barfield, and respectfully represents as follows:

1. The Complainant and the Respondent, Larry Barfield, Jr., were married July 11, 2012.
2. The Complainant and Respondent are both over the age of eighteen (18) years, are of sound mind and neither is a member of the Armed Forces of the United States of America.
3. The Complainant is domiciled in, and has been an actual bona fide resident of the state of Virginia for at least six (6) months immediately preceding the filing of this suit.
4. There is no other suit for divorce between the said parties hereto pending in any other jurisdiction.
5. The parties to this action last cohabited as husband and wife in Washington County, Virginia.
6. There was one child born to Larry Barfield, Jr. and Elizabeth Barfield prior to the marriage of the Plaintiff and Respondent. Said child namely, James Barfield, born September 4, 2001, is the step-child of the Plaintiff. There were three children born out of wedlock to the Plaintiff and the Defendant namely, Jesse Barfield, born July 19, 2006, Jay Barfield, born March 3, 2008, and Jeslynn Barfield, born March 9, 2009; There are no more children of the expected.
7.
