Pat Morse moved and Von Beal seconded a motion to approve the meeting minutes from 12/21/2020. The motion passed with Donald Ridgeway abstaining.

Pat Morse moved and Reddy Brown seconded a motion to approve the warrants dated 1/12/2020 as presented. The motion passed unanimously.

Reddy Brown moved and Laurie Eliot-Shea seconded **Resolution 12012020** Pay increase of \$1.00 an hour for Village Service employees and 2% increase for water/sewer operator. (Third reading) Motion passed unanimously.

Von Beal moved and Reddy Brown seconded **Resolution 01012021** to establish a line item fund for the Opera House in the budget and to transfer \$98,750.00 from General Fund to Opera House fund. (First and only reading, Section 4 waives three readings). Motion passed unanimously.

Pat Morse moved and Von Beal seconded **Resolution 01022021** to create a new Water Plant Capital Project Fund, in the Village of Richwood (first reading). Motion passed unanimously.

Pat Morse moved and Donald Ridgeway seconded **Resolution 01032021** to rename the Capital Project Fund line item to the South Franklin Street Phase 2 Capital Project Fund and to accept payments to be used to fund the improvements on South Franklin Street in the Village of Richwood. Motion passed unanimously.

Mayors Report:

Mayor reports that the funds are available with paperwork to be filled out on the Capital Budget grants. All three grants were approved for the village. They are all through ODNR.
