You centralize your giving and record-keeping in one location.

IRA Charitable Rollover

If you are 70 1/2 years old or older, you can take advantage of a simple way to benefit our parish or school and receive tax benefits in return. You can give up to \$100,000 from your IRA directly to a qualified charity such as ours without having to pay income tax on that money. This law no longer has an expiration date, so you are free to make annual gifts to our organization this year and well into the future.

Those considering a planned gift should consult their tax advisor. Planned giving can provide significant benefits not only to St. Mary, but to the donor as well. Every person's situation is unique, so it is important to seek professional advice to ensure that the path chosen is the most beneficial for the donor as well as for the recipient.
