

2. Self attested copies of income tax current assessment order/income tax return file. Service tax registration certificate, GSTIN registration certificate.
3. Balance sheet for the last three years.
4. Earnest money deposit Rs. 20,000/- along with tender in favour of Jharkhand Silk, Textile and Handicraft Development Corporation Limited payable at Ranchi.

**Other terms and conditions:**

- VII. In case of any dispute, courts in Ranchi will have jurisdictions.


**Tenders Document Submission**

- III. Third envelope should subscribe tender for fabrication and construction of stalls for "Kuchai Silk Expo 2018, Pune".
