Brokerage Fees:

Advances:

Advances are only given after trailer is loaded.

- *\$0 fee for advance company checks - Checks can be picked up in our office
- *\$15 fee for each comcheck issued (including comcheck settlements)

Settlements:

- *M&G does not accept faxed BOL's, we only accept original Bills of Lading.
- *Pays same day, with clean Bills of Lading at no extra cost.
- *All settlement sent in by mail, will be sent out by mail same day received unless noted.
- *For overnight shipments, please include a prepaid label from an express carrier service, or we can pay for the overnight fee from your settlement at no extra cost.

Comcheck Settlements:

- *Quickpay service available for 2% of settlement Rate, with original bills of lading.
- Comcheck fee applies for all comchecks given in settlement.
