## **Buyer agrees to the following**

- Under no circumstances will this cat or kitten be sold, leased or given away to any pet store, research laboratory, breeding mill or similar facility
- Kittens are held by deposit only, and deposits are non-refundable. The balance on all kittens is due at or before the time you take your kitten home. Kittens can go to a new home at 10-14 weeks of age, depending on the kittens readiness to leave their mother.
- Quoted prices on cats or kittens do NOT include shipping charges. Shipping is an additional \$350.00 in most cases.
- There is a \$5.00 boarding fee per day if you do not pick up your kitten on the agreed date. Any sold kitten not picked up by the age of 14 weeks will be charged a \$5.00 per day boarding fee.
- Seller reserves the right to refuse the sale of any cat or kitten at any given time until cat or kitten has been placed in their new home. If sale is refused then any money paid on said cat or kitten will be returned, and this contract will be null and void.
- If this cat or kitten is found to be neglected or mistreated, Buyer will surrender said cat or kitten to Seller immediately.
- Under NO circumstances is this cat or kitten to be put to sleep prior to approval by Seller. Failure to do so will render any guarantee null and void.
- **This cat or kitten will never be declawed unless under special circumstances that Seller must agree to before procedure is carried out.**
- No cash refunds, and all deposit are non-refundable.

# Health Guarantee

Health is guaranteed for a period of 72 hours from the time the cat or kitten leaves the possession of the seller. To validate this guarantee, you must take the cat or kitten to your veterinarian (at Buyers expense) within this said time. If the cat or kitten is found after such examination to have any type of life threatening problem it may be returned and a replacement cat or kitten offered as available. All shipping expenses from the date of sale are the responsibility of the Buyer. Once the cat or kitten leaves the possession of the Seller (RemarkableRags/Jenna Isaacs) cannot be held responsible for any veterinary bills or charges incurred on said cat or kitten.

Should the cat or kitten die within one year of age as a result of a congenital defect (unknown at time of sale), said cat or kitten will be replaced ONLY if an appropriate necropsy is preformed by a licensed veterinarian, and a veterinarian certificate is provided showing proof of cause of death. A replacement cat or kitten of comparable quality and value, as available, will be made at the discretion of the Seller. There are no cash refunds.

**This contract is legally binding to both parties involved. It applies only to the Buyer and the Seller in this transaction and is non-transferable to other parties. All of the conditions are stated herein, and signed for by the Buyer, and Seller. No agreements implied verbally or otherwise are applicable.**
