TITLE: AN ORDINANCE TO ADOPT THE MILLAGE RATE FOR THE TAX YEAR 2021 FOR AD VALOREM TAX TO BE USED FOR GENERAL OPERATING PURPOSES.

Town Clerk, Veronica Brown read the Ordinance by Title and advised the millage rate will remain the same as the previous fiscal year. There were no questions or concerns from the Board. BE IT ORDAINED by the Board of Aldermen of the Town of Greenwood, Parish of Caddo, State of Louisiana, in regular and legal session convened, and conducted in accordance with the open meetings law and the requirements of Louisiana Constitutional Article 7, Sec. 23(C), that the following millage rate be and is hereby levied upon the dollar assessed value of all property subject to

ad valorem taxation within the town limits of the Town of Greenwood for the year 2021 for the purpose of raising revenue for general operating purposes:

General Fund 9.95 Mills

BE IT FURTHER ORDAINED that the Assessor of the Parish of Caddo shall extend upon the assessment roll for the year 2021 the taxes herein levied; and

BE IT FURTHER ORDAINED that the taxes levied herein shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

She also inquired on the salaries of the Police Officers and Police Chief Shayne Gibson responded accordingly but affirmed that Greenwood is comparable to other town/villages of our size and larger.
