AmeriDrive, herein after referred to as "The Driving School" agrees to provide applicant, hereinafter referred to as "Student", 24 hours of		
classroom instruction and 8 hours (four- two hour sessions) of practical driving instruction based on the Ohio Driver Training Curriculum. All		
driving will begin and end from an AmeriDrive location. State of Ohio regulations require The Driving School to make available all training		
within six months from date training begins and the student must complete by this date, which is (fill in with date 6 months from class		
starting date) Failure to complete within six months will require the student to register as a new student with all		
applicable fees to be paid. Should a student be unable to attend available training sessions offered, the school is relieved of the aforementioned		
obligation. Regulations prohibit more than three hours of training to be conducted in any one day. The Driving School shall furnish a licensed instructor and a motor vehicle for instruction. Students attending classes at Buckeye Local and Cadiz must complete driving from the		
AmeriDrive location in St. Clairsville or Wintersville Shadyside High School students must complete driving from the St. Clairsville		
AmeriDrive location. Total program fee is \$350.00 . One half of the fee is required to be paid the first day of class.		
All students must bring to class a self-addressed stamped envelope if they want the certificate mailed, otherwise, it must be picked up in the		
St. Clairsville office at 157 East Main Street. If balance is paid in full, students will receive the certificate within 10 business days after		
completing. No driver license test may be scheduled until you have the certificate.

Additional in-car training may be obtained at the rate of \$_\$45.00 per 90 minutes. Students may use the Driving School's vehicle to take a driving exam at a State exam center located in Belmont, Harrison, Jefferson, or Monroe County, Ohio for an additional fee of \$_\$45.00.

The Student may begin classroom instruction, at age 15 years and five months, before obtaining a temporary driving permit. However, the Student is required to obtain a valid temporary driving permit prior to scheduling the practical driving portion of the training. If the Student must cancel a scheduled driving appointment, cancellation must be made a minimum of <u>24</u> hours prior to the scheduled appointment. Failure to do so will result in an additional fee of <u>\$25.00</u>. The same fee shall apply should the Student fail to appear for, or for any reason not be prepared to take, the scheduled lesson. The Driving School reserves the right to deny the Student admittance to any class if the Student is tardy. Should a check received as payment of tuition in whole or in part, be returned due to insufficient funds, the Student may be removed from driving schedule until such check is made good. An additional fee of <u>\$35.00</u> will be charged for any returned check.

The Driving School reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by The Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any firearm or weapon, tobacco product, alcohol, or drug of abuse is strictly prohibited.

Refund Policy:

There will be no refunds. Should The Driving School be ready, willing and able to fulfill its part of the agreement, no refunds will be issued. The Driving School does not guarantee the issuance of a driver's license to the student.

The Driving School shall furnish a certificate of completion to all students under the age of eighteen years, who successfully complete the course. Completion, as defined by the State of Ohio, refers to the completion of the required number of hours, the student's good faith effort having been exercised during the practical driving portion, and the attainment of a score equal to or greater than 75% on the performance measurement. Should Student fail to achieve the minimum passing score on the final exam additional classroom attendance will be required.
