Atlantic County Food Certification Advisory

The Atlantic County Division of Public Health requires all mobile retail food vendors and food service companies to be certified according to state and county regulations. The county may come to inspect your operation at the market. Additionally, your base operating location where you make and distribute your products must also be registered. NO FOOD PREPARED FROM A HOME KITCHEN MAY BE SERVED TO THE PUBLIC.

A "Mobile Retail Food Vendor" means any movable restaurant, truck, van, trailer, cart, bicycle, watercraft, or other movable unit including hand carried, portable containers in or on which food or beverage is transported, stored, or prepared for retail sale or given away at temporary locations.

- If you have not submitted an application to the Atlantic Department of Public Health for the current year, go to www.atlantic-county.org/environmental-health/topics.asp?topicID=148, and fill out an application.
- If you are already approved, fill out and submit a "Mobile Retail Food Application Amendment" before the event.
- If you have already received a license or "approval to operate" in Vineland City or Camden, Cape May, Cumberland, Gloucester, Salem Counties, submit a copy of the original application and a "Mobile Retail Food Establishment Amendment"
- You must submit your certificate of compliance with this application.
