



## **CREATURES-CON 2022 VENDOR FORM**

### **VENDOR INFORMATION**

Spaces are sold on a first com/first served basis. Creatures-Con reserves the right to refuse a vendor if we feel the vendors products are not in line with the themes of this convention.

Each single Vendor Space measures 36sqft and includes 1 6ft covered table, 2 chairs and 2 convention passes. Double Spaces, 72 sqft (12X6) including 2 6ft tables and 2 chairs are also available. Pipe/Drape is NOT INCLUDED, but feel free to bring your own pipe frame and banner as long as it fits within your designated space. Please do not attach banners/signs to the walls. You may also bring shelves and an extra table as long as it fits within your designated space. Power is not available. Seller's permits are highly encouraged as you may be asked to present them during the event.

Vendor load in/set up is 7am to 10am Sunday August 7th. Dealers Room hours are 10am to 6pm. ALL VENDORS ARE ASKED TO STAY FOR THE FULL EVENT. All vendors are expected to be set up and ready when the doors open at 10am. Vendors must leave their spaces clean and free of trash after the event.

### **VENDOR'S CONTRACT**

Vendor Spaces are \$85. Double Spaces are \$160, a \$10 savings. 50%, (\$42.50 or \$80), non-refundable deposit due at sign up to reserve your space. The remainder of the charge is due Monday, July 25th. If the final payment is not made, or we do not hear from you by Monday August 1st, your space will be released. CONTACT CREATURES-CON ASAP IF YOU MUST CANCEL TO ALLOW US TIME TO ATTEMPT TO RESELL YOUR SPACE.

### **TERMS AND CONDITIONS**

CREATURES-CON WILL ADHERE STRICTLY TO COVID RESTRICTIONS SET BY CONTRA COSTA COUNTY, THE STATE OF CALIFORNIA AND THE FEDERAL GOVERNMENT IN EFFECT ON THE DATE OF THE EVENT. WHERE THERE IS ANY UNCERTAINTY, CREATURES-CON WILL ERR ON THE SIDE OF CAUTION WHERE ATTENDEE, VENDOR AND GUEST SAFETY IS CONCERNED. SUCH RESTRICTIONS MAY INCLUDE MANDATORY FACE COVERINGS AND/OR PROOF OF VACCINATION

OR NEGATIVE TEST. SIGNING ON AS A VENDOR FOR CREATURES-CON INDICATES ACCEPTANCE OF THIS POLICY.

By renting the space and signing the vendor's contract you accept that Creatures-Con, the Concord Plaza, nor anyone employed or associated with them CAN NOT be held responsible for theft or damage at, before or after the event, nor shall Creatures-Con or the Concord Plaza be held responsible for weather, fire, flood, earthquake or any Act of God or State or Federal emergency that may close the event. Upon this happening, refunds will be equal to, but no more than, the amount returned to Creatures-Con for such an event.

You agree that you shall be held responsible for any and all damages to the venue or any person due to negligence or misconduct by you or your agents. Guests are booked on a good faith basis and only announced after we have confirmation of their appearance, but cancellations may happen for which Creatures-Con and the Concord Plaza may not be held liable.
