II. Update from Dr. Otstot:

Dr. Otstot announced we have been approved for the A+ site visit. March 22nd. There will be a tour of school lead by 2 students. Staff meeting with teachers. Parent meeting with school, community and business leaders. A meeting with classified group of staff (nutrition, etc) Digital art classes have started videoing students and staff re: "Why we are an A+ school" During this process we have discovered a lot of reflection. No school is perfect but we are learning and excited about this visit. We won't know until April whether or not we will receive the A+ designation. That's why we moved the Art and Garden Walk to April, as well.

From 2014-16, K-5 students at Copper Ridge School have participated in a weekly Spanish exploration program. This program has been generously funded by our CRPTO. Funding

consisted of approximately \$12,000 annually for a classified Instructional Support Specialist-Spanish, as well as \$3,000 for curricular materials. At this time, site and district-level discussions are taking place to determine K-5 world language programming. Several options including staffing and instruction, as well as curriculum access (online or in-person) are being reviewed. In an effort to gather input from various stakeholders, we are seeking your feedback to support the direction of the Copper Ridge School: K-5 Spanish exploration program. It may be a. 45 minute special. 5 day rotation. It would be a special like PE, Art or Music.
