**If trial does not fill, Day Of entries will be accepted**

**Entries will be accepted as received, maximum of 10 dog entries per envelope. Your entry must be complete with BHA number and signed liability waiver. We reserve the right to limit entries to fall within the time constraints of a judging day, a maximum of 120 runs per day.**

Classes offered each day: Instinct Test (2 on Saturday, 1 on Sunday), Novice, Open, Senior, Master and Crazy 8s. Trial 2 will follow ½ hour after completion of Trial 1. Move ups will be allowed between trials if information is brought to the Trial Secretary within ½ hour of the conclusion of your class (must be before the class you are moving into begins if that is shorter than ½ hour). Facility will open at 8:00 am. Saturday briefing will be at 8:30 and first dog ready for Instinct Test at 9:00 am; Sunday briefing will be at 8:15 and first dog ready for Instinct Test at 8:30 am.

Entry fees are \$12 for Instinct, \$20 for Novice and Open, \$25 for Senior, Master and Crazy 8s. Day Of entries will be accepted by ½ hour prior to trial start time. Day Of entry fees are \$5 additional per class. \$50 NSF fees. **Barn Hunt registration numbers** are required for valid entry, the number can be obtained on the website: [www.barnhunt.com](http://www.barnhunt.com) Make checks payable to: **RMDS**

**Awards:** Ribbons will be awarded for all Qualifiers in the Regular classes and the Instinct Test. Placement ribbons will be awarded for First, Second, Third and Fourth place. Rosettes will be awarded for new titles. High In Class will be awarded for Novice, Open Senior and Master in each trial.

### Exhibitor Information

1. Barn Hunt information, dog registration, rules and more can be found at [www.barnhunt.com](http://www.barnhunt.com)
2. This barn is on private property. There is livestock on the property. They will be contained away from the trial area, but please do not molest the livestock.
3. The trial will be held indoors/outdoors on dirt and/or cement. The barn is not air conditioned. Bring what you need to keep yourself and dogs comfortable, ie chair, crate, shade, water, etc. Porta potty will be on site. More than likely crating will be outside.
4. All dogs must be under control and on a short leash while on trial grounds except while showing. **Flexi leashes and electric collars are not permitted** on the trial grounds. Electronic collars, bark collars and head halters are not allowed to be used on the trial grounds. Prong collars are not allowed in the ring. Dogs are required to run 'naked' and should be brought into the ring with collars/harnesses/slipleads which can be easily and quickly removed and replaced.
5. There is no smoking in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also.
6. Please pick up after your dog and dispose of waste in appropriate containers outside building.
7. **Bitches in season** may compete at Barn Hunt trials. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial committee prior to the trial and inform all exhibitors at the judge's briefing.
8. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
9. Every attempt will be made to hold this event as scheduled. In the event of an "act of God" such as flood or fire, or civil disturbances or any other causes beyond the control of the organizing committee, an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
10. **Disruptive dogs** will have to be crated outside. If your dog cannot handle other dogs or people walking past their crate, plan to crate outside. Please bring adequate shade.
11. Please make sure your crate is secure as the dogs may be highly excited. If your dog is overly excited do not leave him/her unattended.
12. **Lunch will not be provided.** There are fast food restaurants approximately 15 minutes away.
