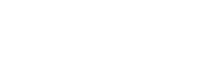

We further understand that if such travel is to occur following the student’s exchange year of _____, the permission and release shall apply to any and all travel thereafter, including travel from the host town, it being understood the student is no longer under the auspices of the Rotary International Youth Exchange Program and is traveling as an individual without the sponsorship of Rotary International, host and sponsor Rotary Districts, host and sponsor Rotary Clubs, without Rotary sponsored insurance and without a Rotary sponsored visa.
