SITE INFO: This trial will be held in one ring indoors on packed dirt. Crating is on dirt in the arena building. You may set up your crating space Monday morning beginning at 7 am. We will be unloading equipment and setting the course on Sunday night beginning at 4:00 pm. The more people we can get to help the faster it will go.

#### **DIRECTIONS TO THE TRIAL SITE:**

From I-5 (North or South) take Exit #9 (in Washington), head East on 179<sup>th</sup> Ave. past 72<sup>nd</sup> Ave. (signal light). Turn right on 92<sup>nd</sup> Ave. (about a mile further). 92<sup>nd</sup> Ave. curves to left and becomes 156<sup>th</sup> St. THEN Turn into driveway at 9628 NW 156<sup>th</sup> St. (North side of street)
