1. Call to Order

3. Audience of Citizens

Items not on the agenda may be addressed during the "Audience of Citizens". **The Board may respond to criticism, ask that staff review a matter, or place an item on future agenda.***

Public comment is limited to three (3) minutes and may be shortened at the discretion of the Board's President. Please state your full name, address and organizational affiliation if applicable.

4. Executive Session

A.R.S. § 38-431.03 permits an executive session or closed meeting to be held for discussion and consideration of any of seven particular subjects. A majority of the members of the Governing Board must vote to convene an executive session during a public meeting held prior to the executive session. The general public is properly excluded from such a session. Only those individuals necessary to the conduct of such a meeting may be present. All matters discussed in an executive session must be kept confidential by those attending. No vote may be taken during an executive session. Any final action on an item discussed in an executive session must be taken during a public meeting. A.R.S. § 38-431.03.

The purposes for which an executive session discussion may be held are the following:

- A. Personnel matters involving a specific individual.*
- B. Confidential records.*
- C. Student discipline matters.*
- D. Legal advice provided by the public body's attorney.*
- E. Discussion of pending or contemplated litigation with the public body's attorney.*
- F. Instruction of designated representatives concerning negotiations with employee organizations.*
- G. International and interstate negotiations and negotiations by a city or town with a tribal council.*
- H. Instruction of designated representatives concerning negotiations for the purchase of real property.*

6. **Approve the FY21 Audit and Legal Compliance Questionnaire**

CALENDAR TRACKING & ATTENDANCE TRACKING

INSTRUCTIONAL METHOD: Remote

EXPLANATION OF METHOD: Students will login into their regular classroom via Google Meets and participate in synchronous learning.

ATTENDANCE TRACKING: Student attendance procedures will be the same as if the student were on-site and in-person. Attendance is taken during homeroom (in the morning) and if a student logs out of their Google Meets session and does not return to the session within ten (10) minutes, they will be counted as an early departure for the day (same process as if they were signed out of school by a parent or guardian). If/When they return, the time they logged back on to the Google Meets session will be noted (using the same process if they were to return to campus and signed-in at the office).
