Re: Invoice for Payment of North Delta Water Agency Assessments and Notice of Intent to Initiate Litigation if Payment Not Received by June 30, 2017

Dear Director Bonham:

This firm represents the North Delta Water Agency ("Agency" or "NDWA"). The Agency levies an assessment on lands within NDWA boundaries in proportion to the benefits they receive from the Agency's continued operation, maintenance, enforcement, and administration of the Contract for the Assurance of a Dependable Water Supply of Suitable Quality ("1981 Contract") between NDWA and the California Department of Water Resources ("DWR"). As consideration for DWR's performance of the 1981 Contract, the Agency pays a fee to DWR that is adjusted every five years pursuant to Article 10(b) of the 1981 Contract. To pay this fee and fund the Agency's costs associated with the 1981 Contract, the Agency levies an annual assessment against the lands within Agency boundaries.

According to NDWA's assessment roll, the California Department of Fish & Wildlife ("CDFW") owns 17,438.77 acres of land within the Agency's boundaries. In accordance with the current NDWA fiscal year ("FY") 2016-17 assessment rates, and the invoice attached hereto as Attachment A, the total amount due for all CDFW parcels is \$139,541.90.

In accordance with an agreement executed in 2008, DWR previously allowed NDWA to deduct the total annual assessment owed by CDFW from the annual 1981 Contract fee. That agreement, however, expired in 2011 upon the Agency's adoption of an increased assessment in compliance with Article XIII D of the California Constitution ("Proposition 218"). According to a letter dated December 7, 2017 (attached hereto as **Attachment B**), DWR will no longer offset the Agency's fee under the 1981 Contract to account for CDFW-owned lands. In the absence of such an offset, CDFW must pay the assessments levied by the Agency on CDFW-owned lands. *See* Cal. Const., Art. XIII D, § 4 ("Parcels within a district that are owned or used by any agency, the State of California . . . shall not be exempt from assessment . . . .").

Therefore, NDWA hereby demands that CDFW pay the Agency the entire annual \$139,541.90 assessment by June 30, 2017. If full payment is not received by this date then a 10% penalty will immediately apply plus an additional 8% interest annually.

In addition, we hereby give notice that the NDWA board of directors has authorized Downey Brand to initiate litigation against CDFW if the Agency does not receive payment of the foregoing amount by June 30, 2017. Please call if you have any questions.

Dear Ms. Terry:

This letter notifies North Delta Water Agency (NDWA) that its annual payment obligation to the Department of Water Resources (DWR), adjusted for the five-year period 2017 through 2021, is \$617,836.

The determination of the annual payment obligation is in accordance with Article 10(b) of the January 28, 1981 "Contract between the State of California Department of Water Resources and the North Delta Water Agency for the Assurance of a Dependable Water Supply of Suitable Quality" (Contract) as amended on January 21, 1997 (Amendment).

The mean of the State's latest projected Delta Water Rate for the five years is \$68.79 per acre-foot. The adjusted payment under Article 10(b) of the Contract using the mean of the State's latest projected Delta Water Rate for the five years is \$1,169,430 or (\$170,000 x \$68.79 / \$10). This calculated adjusted payment of \$1,169,430 is 124.44 percent more than NDWA's previous Article 10(b) adjusted payment of \$521,050. Article 10(b) further states that no adjusted payment shall exceed the previous payment by more than 25 percent. As a result, the adjusted annual payment obligation to DWR beginning January 1, 2017 is \$651,313 or (\$521,050 x 1.25).

Article 6 of the Amendment specifies that NDWA may permanently reduce its annual payments due under Article 10 of the Contract by a percentage equal to the percentage of acreage of land owned by DWR within NDWA's jurisdiction compared to all lands within NDWA's jurisdiction. The total land area within NDWA's jurisdiction is 287,860.99 acres; from that amount DWR owns 14,785.80 acres. NDWA's annual payment for 2017 through 2021 may be reduced by 5.14 percent or ((14,785.80 / 287,860.99) x 100). The credit DWR will apply to the Contract payment for lands owned by DWR is \$33,477 or (\$651,313 x 0.0514).

A May 21, 2008 agreement between DWR, Department of Fish and Game (DFG) and NDWA temporarily allowed for reduction in NDWA's annual payment obligation to compensate for payments not received from DFG for assessments levied upon lands it owns within the agency. Under the agreement, this arrangement terminated when a new assessment was adopted by NDWA, which occurred in May of 2011. DWR is currently negotiating with DFG regarding terms of a new agreement replicating the 2008 agreement. Until this new agreement is in place there is no contract authority for DWR to credit NDWA for DFG owned lands within NDWA's jurisdiction.

NDWA's adjusted total annual payment for 2017 through 2021 is \$617,836 or (\$651,313 – \$33,477). Per Article 10(a) of the 1981 Contract, NDWA shall make annual payments to DWR, one-half on or before January 1, and one-half on or before July 1 of each year. DWR will send an invoice shortly for the first installment payment.
