## **Detailed Expression of Interest (EoI) for Rent**

Arunachal State Rural Livelihoods Mission (ArSRLM) Itanagar invites applications along with all manners of attachments via email (to patoceoarsrlm1@gmail.com) in prescribed format from interested owner(s) / landlords willing to provide a building according to essential and desirable conditions as mentioned below, for its State Office on monthly rental basis by 16<sup>th</sup> August 2019.

Applications received after 1600 hours on 16<sup>th</sup> August 2019 shall not be considered. Applications where the concerned property does not correspond to conditions as mentioned below shall also be rejected.

#### 1. Conditions -

- a. A RCC Building with minimum built-up area ofat least 12000 square feet excluding parking area is required.
- b. Parking area should be approximately 3500 square feet toaccommodate at least 15(fifteen) four wheelers and 20(twenty) two wheeler vehicles at the same time.
- c. The building needs to be located not more than (7) seven kilometers from Arunachal Pradesh State Civil Secretariat Building.
- d. The building should be protected by a RCC boundary wall.
- e. The building needs to have a separate entry and exit gate.
- f. The building needs to be not more than 200 meters away from the main road.
- g. The building needs to have provision to support 24x7 water supply.
- .h. The building needs to have proper drainage for rainwater and havehealthy and hygienic surroundings.
- i. The owner / landlord needs to provide the building on rent for ten years, where the mutually agreed rent shall be payable on monthly basis.
- j. The owner / landlord needs to do the entire interiors as per requirement of ArSRLM. ArSRLM shall provide a detailed interior layout for office space to the landlord in this regards.
- k. No portion of the building proposed to be provided on rent can provided to any other entity / agency / individual / group / association etc.
- I. ArSRLM shall not increase the monthly rent that is initially decided for 1<sup>st</sup> five years or 60 months whichever is later, from the date of agreement.

Officials representing ArSRLM will visit all locations that are shortlisted for on-site inspection. The decision of the competent authority shall factor the report of on-site inspection.
