- II. Acceptance of Minutes from Meeting Held on July15, 2021

III. Presentation:

- A. Second Session Update: Emma Tippet, Ann Johnson's office, second session wrapped up with some victories. Virtual education was funded, 13th check approved for teachers. 3rd special session starts Monday which will include redistricting, delay due to census turn ins and covid. 1 more public hearing Sat, Oct 9th can sign up here . https://capitol.texas.gov/tlodocs/87R/schedules/html/C0802021091811001.htm Federal funding from covid relief and dispersing. Depart of family services, funneling \$ to them to make sure ensuring CPS has the resources they need. Anti-trans legislation popping up again. Hosted a community round table with neighborhood leaders. Will start having pop-up district meetings so folks don't have to drive to Ann Johnson's office, they are coming to you. District also partnered with CofH with a supply and food drive for Louisiana after hurricane Ida. Honored Lamar High Schools new bldg. Assisted Methodist Hospital with helping with Covid. Honoring Rice University's President who is retiring after 18 yrs of service to the University.
 - **B.LED Billboards:** Mike VanDusen, Mayor Turner proposing to allow LED Billboards. City representative was not present to give an update. Mile will try and get additional information.
 - **C. By-Laws:** Mike VanDusen, There are deficiencies and lack of clarity of what constitutes a quorum and voting rights. Next meeting, October 21st, will be a 1st vote. November 18th meeting will be a final vote to put them into effect. Anyone who has comments, suggestions etc. reach out to Mike.

IV. New Business:

- A. Detering One Way Project: Suspected that the adjacent business owner right there is wanting the one way in place. However this will dump all the traffic into residential area instead of onto Washington. There will be a stakeholders meeting in October, date has not been set. Feedback from those who live nearby and will be effected are encouraged to attend. Meg, spoke about how Reinerman was changed to one way north bound, dumping into the neighborhood and what problems is has caused. Reinerman is parallel to Detering a few blocks to the east. Problems are: traffic, no emergency apparatus can get through, accidents, some residents can't even get out of their driveways because of being blocked in by traffic.
- B. - **A. Bicycle Advisory Committee:** Mike VanDusen, 2 projects going on, 1: MKT bridge once they started working on repairs they've come across additional damage that needs to be dealt with. 2: White Oak Trail connector between MKT bridge and Studewood has been approved.
 - B. Planning Commission Updates: Mike VanDusen, no updates
- C. Quality of Life Updates: Stacie Fairchild, East end of Washington, the place that used to be Benjis is reopening as a bar, owned by some company from out of the country wanting to change the way Houston bar scene is. Loud noise units need to be more attentive. On the stats it reflects no citations were issued for August and September. Meg noted the fights, gun shots, drunks passed out in yards, trash, etc. Calls to non-emergency tend to be on hold for at least 15 minutes, Sgt. Nguyen, state that over 257 citations had been issued to bars, they just pay them and accept that it's part of doing business. More sound units are needed.
- **D. City Council and Department Updates:** Yolanda Alvarado, DA Oggs office, DA's office is giving out free gun locks, email Carpenter_Anna@dao.hctx.net. Jack Valinski, gave an update that 311 app still has issues, not sure when it will be fixed. Not user friendly for phone users.

Announcements, and Open Comments: Tami Hamilton, Flyers given out about a free concert October 14tg, 6:00pm featuring Monarch Chamber Players, will be behind Memorial Elementary and sponsored by Crestwood Civic Club. They will be planted along Wescott between Memorial and Feagan starting October 14th. Angie, has concerns regarding large bicycle groups blocking the entire street on Washington near the roundabout, blocking cars and causing traffic jams. Mike will bring it to the attention of the Bicycle Advisory Board. On 9/24 Department of Defense had training throughout the city, lots of helicopter noise may be heard during the exercises.
