A. New Well Project

During flushing of the new line it was determined that there is an air lock, and water is draining back after the pump shuts off. A check valve will need to be installed in the well.

B. Republic Services Invoice

Mr. Weidner contacted Republic Services and sent a copy of the invoice to Heather Lamson requesting payment. She is to get the invoice to the appropriate person for payment.

C. Sump Pit

Mr. Dale Albert had a meeting with Choice One Engineering and Reichert Excavating. It has been suggested that the pit be replaced with a stainless steel liner. Choice One will be providing a quote for the engineering services.

D. Church of God Meters

The meter for the house has yet to be replaced.

E. Filter Beds

Mr. Albert estimated the cost of replacing the bedding material at a little over \$2,000. This project should be able to be done next year without requiring additional appropriations in the budget.

NEW BUSINESS:

A. 2016 Water Department Budget

An updated priority list was given to the board. They are still waiting on an estimate for the purchase and installation of a security system at the plant.

B. Water Clerk Retirement

A letter of resignation was given to the board from Ms. Lones, the water clerk. The letter stated a retirement date of January 8, 2016.
