# CAN YOU THINK ON YOUR FEET?

ould this e-mail have been written by you?

"I was wondering if you could help me with a growing problem. I have lost a great deal of confidence in my public speaking and find my mind goes blank when I am put on the spot by senior colleagues in academic meetings. I manage OK with organized speaking and giving presentations flounder but and sound unconvincing when giving answers to impromptu technical questions. This is really destroying my credibility. My problem is talking with confidence under pressure! Do you have any helpful tips for this kind of situation?"

First, you should know you're not alone. No one enjoys being put on the spot or having to answer unexpected or difficult questions. It's stressful! But there's good news. It's possible to learn how to think on your feet and speak clearly, concisely, and confidently. It's a matter of practicing a few skills and tactics.

### Learn How to Relax

First, it's important to know how to relax when you are under pressure. Proper breathing techniques help. In this case, it's critical to slow down your breathing and to get rid of your inner critical voice.

Even if you struggle with abdominal breathing, just deepening and lengthening your breath stimulates the relaxation response. Many of the things that happen when we're stressed, such as increased heart rate, fast breathing, and high blood pressure, all decrease when we breathe slowly and deeply.

To quiet the "mind chatter," you can focus on your breath, or perhaps use meditation techniques. Another longer term idea might be to try yoga, which research has shown helps people with breathing, relaxation, and the ability to focus.

It's a good idea for you to get in the habit of repeating the questions. Repeating the question gives you a bit more time to think about your response.

### Listen and Pause

Of course, the ability to focus on the questioner and really listen without distraction is critical to the success of your answer-- especially for technical people. You need to listen carefully so that you fully understand the question. It helps to look directly at the questioner and, if necessary, ask him or her to repeat or clarify the question. Often the second time around, the question is more concise and much clearer.

In addition, it's a good idea for you to get in the habit of repeating the question. That helps, because at times, you'll want to slightly rephrase the question. Maybe to make it less aggressive, more narrow, or even broader in focus. Especially when you are feeling pressure, repeating the question gives you a bit more time to think about your response.

Next, always pause before you respond. As long as you don't have a look of panic on your face, you'll look thoughtful, careful and respectful. So, pause, even if you know the answer and especially if you feel attacked. Blurting out a response without thinking it through just makes you look insecure and anxious. A thoughtful pause reminds you to slow down and collect yourself and your thoughts.

### Organize

Pausing also lets you choose the best organization structure. Stress seems to make people answer either too briefly or ramble on. When responding to an impromptu question, the idea is to structure your response for clarity, brevity, and impact. By learning a few impromptu response structures, your answers will always sound organized and confident.

### Impromptu Response Structures

•The first one is called PREP: position, reason, example, position. In this model, first you state your position on the topic, then you state your reason for taking that position. Next, you provide an example or story that supports your reason. Finally, you summarize by restating your position.

•The second structure is called PEP: point, example, point. It's easier than the first one and can be used to answer a wider variety of questions. In this one you start by briefly making a point or stating a key idea or objective. Then you give an example or story that proves your point. Then you wrap up by restating the main idea, or your main point. When you are short on time, this is the way to go.

•The final structure calls for you to quickly think of a way to divide up your response; e.g., divide and conquer. There are a few classic two and three part divisions that you'll want to memorize such as: past, present, future; problem, solution; cost, benefit; us, them; ideal, real; low, medium, high. Of course, there are many of these, so try to practice the ones that are common to your field. These are easy; you just pick an appropriate division and then include a little bit for each section.

### Practice

The best way to learn how to organize on the fly and respond with confidence is to practice. Start with easy questions such as, "Where do you like to vacation?" If using the PEP structure, you might say something like this:

"I like to relax and enjoy warm, sunny, tropical beaches for my vacations. For example, I'll be heading to an all-inclusive resort in Panama this year. We'll be able to scuba dive, swim, kayak and just chill on the beach and my motherin-law, who happens to live only 25 minutes from the resort, will takes care of my girls."

However, using the divide and conquer structure, you might say something like this:

"Before I had my twin daughters I spent vacations in warm, tropical beaches like Belize and Grand Caymen. However, for the past five years my only vacation was a few short hours of quiet when someone else was watching my girls. However, in a few short weeks, we'll be vacationing in Panama, relaxing by the ocean and the second largest man-made pool in the world. I can't wait!"

If you practice all of these techniques when the questions are easy and you're not under pressure, you can learn the structures quickly. Then, when you are put on the spot, you can easily relax, listen, organize, and respond.

Whether you are attending a meeting, interviewing for a job, presenting a proposal, selling an idea, or handling a question and answer session, being able to talk clearly and concisely -- at a moment's notice -- is a critical professional skill.



### NALS OF MICHIGAN DIRECTOR'S REPORT By Nancy Thomas, PLS



On June 17, 2017, I attended the NALS of Michigan Quarterly Meeting held in Lansing at the State Bar Building. Paula Steffey, PP, CLP-SC, Tami Carl, PLS, and Kim Snow, PP, PLS, from our chapter also attended. Eighteen members total were present, with sixteen voting members.

**OF MICHIGAN** The day started with a seminar by Benjamin Eichler, a financial planner from the Principal Financial Group in Williamston. He gave an interesting presentation and left us with a lot of material to consider.

President Heidi Hopper presided at the business meeting. Officer and committee reports were presented. Approval was given for a drawing to fund one NALS of Michigan member to the NALS Forum in Norfolk this fall. Payment will cover the registration fee, NALS Foundation dinner, scavenger hunt, and escape room event. More information will be out soon about this drawing. Approval was also given to fund Paula Steffey to the NALS Forum on behalf of the state association.

Vice President of Membership and Marketing Paula Steffey reported the state association has 202 members, which is 16 less than in June of 2016. She also reported that NALS of Northern Michigan intends to dissolve its chapter and join with Grand Traverse. The Calhoun chapter also intends to dissolve, and its members have the option of joining Jackson or Kalamazoo. Paula reminded everyone that the 25th of the month is the deadline to submit information for the marketing newsletter.

Vice President of Education and Certification Jodi Velez reported the Certification Committee is still looking for a chair. She will send an e-mail to chapter presidents seeking volunteers. If a chapter is interested in an officer outreach (e.g., visiting their chapter), please contact Jodi. Jodi also announced those who passed the March 2017 certification exams, including our own Cathy Zackery, CLP!

Report on the 2017 Annual Meeting: The 2017 Annual Meeting Committee reported a deficit of \$731.84. This difference was split between NALS of West Michigan and NALS of Michigan. Those donations will bring the Annual Meeting account back up to the \$1000 balance we maintain. We had only 58 registrants this year as compared to 80 last year, which was the greatest factor contributing to the deficit.

Report on the 2018 Annual Meeting: Grand Traverse is the host chapter for the 2018 Annual Meeting, to be held at Shanty Creek in Bellaire April 27-28, 2018. Room rates have been secured at \$89 per night for the hotel, or \$109 for a studio parlor room. Registration fees were approved of \$145 for members, \$135 for student members, and \$155 for non-members. The meeting will run Friday and Saturday, with possibly a Sunday breakfast; the committee is still working on the details.

Report on the 2019 Annual Meeting: NALS of Greater Kalamazoo expressed interest in hosting the 2019 Annual Meeting, but no final proposal is ready yet. Look for more information at the fall quarterly meeting.

The Finance Committee will be selling a Blue Tooth speaker this year, as well as greeting cards to supplement the other finance products that were available previously.

The State Bar of Michigan annual meeting is September 27-29 at Cobo Hall in Detroit. NALS of Michigan will be assisting once again at this meeting. Watch for more information on how you can sign up to help.

The Technology Committee is working on updating the web site. The members approved an additional fee to pay for the update. Our own Cathy Zackery is working on expanding our social media presence, possibly including Instagram.

The Scholarship Fund meeting followed. The members approved awarding one scholarship in 2018 for \$1,000. The Scholarship Committee is also planning another 5K run (second annual) in Williamsburg. They are looking for runners, sponsors, and volunteers to assist on race day. See additional information in this newsletter.

The next NALS of Michigan quarterly meeting will be held September 16, 2017, at the offices of Foster Swift in Lansing. No speaker has yet been scheduled. Stay tuned for more information.


