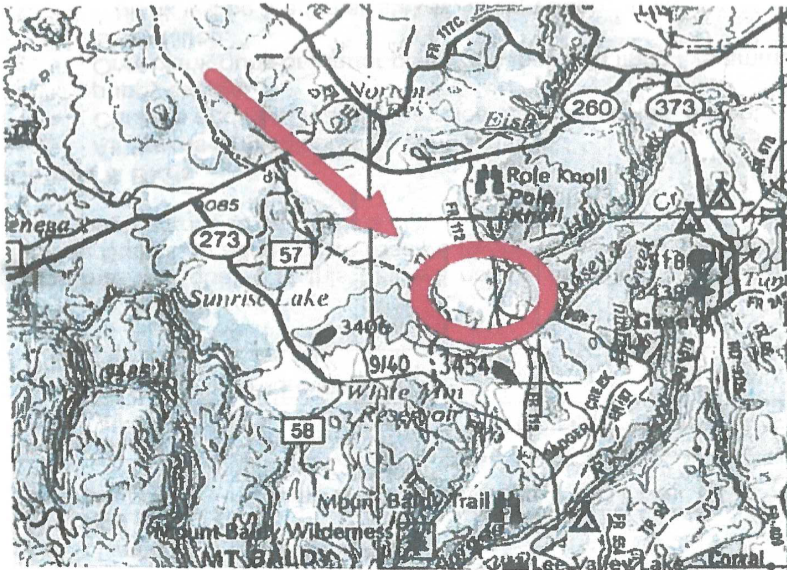
Camping

These Field Trials are being run as a “Flexible Format” event. Entries will be limited to the number of dogs that can be run during all available daylight hours, and entries will close when the limit is reached, even if this occurs prior to the official closing date. The Field Trial committee reserves the right to rearrange the running order of the stakes, and/or substitute judges, and/or add, delete, or change courses, if conditions warrant. We anticipate a full trial, so we would appreciate everyone’s cooperation to be ready and at the line when it is time to run.

Courses and Birds

All stakes are single course without bird field. Quail and/or chukar released in all stakes except puppy stakes. No birds will be released for Open Puppy. Blanks will not be fired in Open Puppy. Horseback handling will be permitted in all stakes except AGD - walking. OGD and Amateur Walking Gun Dog will be call backs for retrieve. Please be responsive and observant and get your dog to the line on time!
