JR D Construction will prepare and submit costs for each section of the project based on options chosen by the Board for review and approval. The pool renovation project includes; replacement of the perimeter fence, extending the fence between the pool and clubhouse closer to the clubhouse to allow more room in the pool area, the wooden deck will be removed and a cool deck installed in the pool area, replacement of the pool coping and tile, a 1200 sq. foot splash pad will be installed in the corner next to the baby pool with several water features for kids of all ages (even the old kids) to enjoy, new shade structures will be installed over the baby pool, splash pad area, and above the deck behind the deep end. JR D Construction will have the final plans prepared for the splash pad for approval and City permit submission.
