Springtime is here on the mountain with 2 snowstorms and cold temperatures in May. After the fire we had by the creek, I have been cutting down dead trees and brush on my property and also removing pine needles around my cabin.

When everyone sees how lucky we all were with this fire, I think it will motivate everyone to do the same. As I walk and drive through our community, I see 95% of our cabins are in great shape as far as debris around them. But the other 5% cause a danger to us all. We have a seasonal fire department which means it is only in operation about 6 months of the year. We, however, have it set up with Duck Creek Fire Department and

Fire Department Update

Spring has sprung and we are officially open for the season! The weather is warm but windy.

I attended a meeting with the Forest Service along with Don Carle on the 3rd of May. We reviewed fire fighting techniques and they also let us know that this will be a high risk fire season. They will issue a campfire ban sooner than later. Just a reminder that fire pits need to be inspected every year. Call the fire dept. for an inspection. There were 3 wild land fires in our general area; one was the fire at Mammoth Creek that was in the last newsletter, a 40 acre fire in Cedar City, and a fire in Hatch, details unknown.

Here are the numbers everyone home owner needs to keep handy:

Fire Dept. 435-682-2700, this number is forwarded to my residence in summer and to my cell in the winter, if I am not at the station. Dispatch 435-676-1134 answers in Panquitch City or 911 answers in Kane County. Both can locate and notify me regardless of my location.

We also responded to 2 calls from Dispatch

- 1. Carbon monoxide Remember to service all heating units yearly just like you would your home units
- 2. False house alarm

Chimneys need to be cleaned every 8 to 10 years, if your smoke is blacker than gray it is a good sign that your chimney is probably full of creosote and needs sweeping.

Our 5 ton is almost ready. We can shuttle water

Panguitch Fire Department to respond the rest of the year, but they are also an hour away. We are lucky our fire chief and assistant fire chief, John and Don live in Cedar City area, but also are an hour away. So it is very important to keep our cabins defendable for fire.

Our HOA is putting a large dumpster out on the 4th of July weekend. At our regular meeting May 24th, at 11am, we will discuss having a large dumpster delivered more often if we need to so we can keep our cabin area clean.

The forest service every year sends our fire chief a letter with requirements on our burn dump. This year we will be putting up some fencing to try to stop driving around our gate. They also do not want concrete dumped there and what is there removed. John Miller, Dick West, and myself removed several loads with more to do. The forest service also wanted a sign put up stating the burn dump is for MCHOA dues paying members only, which we did.

The meeting should be interesting this year, so please try your hardest to attend.

Treasurer's Notes Bill Luthy, Treasurer

We've been up to the mountains twice, already! We drove in both times. It was getting into the 20's at time and pleasant during the day.

I have had a great response on the dues statements I sent out. A couple of people pointed out that I forgot to change the date from last year's statement. Another correction I missed was that the address should be HC 82 Box 1077, Duck Creek Village, UT 84762-8200.

I sent out statements for 640 lots in about 400 envelopes, last year it was over 500 envelopes. It seemed like there was a lot more multiple lot owners this year. My wife, Peg, did a great job folding all of the statements and it seemed like we got them out earlier this year.

We have received \$8,400 in dues payments so far. This represents payments on 168 lots, over 25% of all the lots and over 50% of the improved lots. I hope to get some more checks in but I won't be able to check the mail until we go up for Memorial Day. Someone else may pick up the mail.

We are looking forward to going up for Memorial Day. We hope to get up there a few days early. I have a few projects I would like to get started.

Peg and I are looking forward to a great summer at the cabin. We hope to spend more time there is year.

It will probably be a dry summer so we will have to keep our eyes out for fire danger.

The 4-wheeler roads are closed for the time being because of the spring runoff. The will hopefully reopen before Memorial Day. DO NOT GET CAUGHT ON THESE ROADS, they are ticketing all offenders.

We also have the ice machine up and running, so ice is now available.
