DIXIE DEER SPECIAL SERVICE DISTRICT POLICY FOR WATER USERS

Date of Commencement of Fees and Charges

All monthly charges shall accrue from and after the date that water service is available from the system of the District, whether or not the water service is utilized.

NOTE: Currently, the charges are billed on the 26^{th} of each month, due and payable by the 20^{th} of the following month, as follows:

BASE RATE: 0 gallons to 12,000 gallons \$44.00

12,001 and Up \$4.00 per 1,000 gallons

Monthly Statement

The District shall furnish, or cause to be furnished, to each user, a written or printed statement specifying the water service charge assessed against him/her once very month, or such other regular intervals as the Administrative Control Board shall direct. Failure to receive bills or notices shall not prevent any unpaid amounts from becoming delinquent and shall not relieve the user (Owner/ Renter) from any obligation to make payment.

Delinquencies

Any person who fails to pay their water charges within the due date, which is the 20th of each month, their account will be deemed delinquent. If said delinquencies remain unpaid, the Administrative Control Board will send a written notice of delinquency. If said delinquencies remain unpaid after the date stated on the notice, the Administrative Control Board, at their discretion, will file a delinquency against the property with the Washington County Recorder. The delinquency will include all accrued late charges. When the Notice of Delinquency is processed, as authorized by this Policy and Utah Statutes, an additional charge of one hundred dollars (\$100.00) will be assessed to the delinquent account. After three months (3) delinquent the Administrative Control Board may direct the Water Master to turn off meter and/or remove.

Enforcement of Payment through Legal Process

Notwithstanding any other provision contained in this Policy, the Administrative Control Board may, at its discretion, and in addition to any other method of enforcement, seek payment of delinquent water fees and charges by an action at law. All provisions contained in this policy shall be in effect regardless of whether or not the completed Water User Application has been received and/or you have not acknowledged receipt of the District's POLICY FOR WATER USERS on the Application and Agreement for Water Service.
