Dear members of First Lutheran,

On Sunday, January 28th, First Lutheran will hold it's Annual Congregational Meeting following worship. All Confirmed members of the congregation are eligible to vote. Please find Annual Reports available on our website (FirstLutheranSouthington.org) under DOCUMENTS, or printed versions in the Connector.

On September 24th, we held a special congregational meeting to consider a reduction in staffing. The congregation voted to reduce the Music Director position and eliminate the salary for the Youth Director.

A second, separate, proposal was also considered: my offer to curtail my 4-year, full-time call agreement by reducing my position to part-time. Numerous members voiced their opposition to such a cutback; no one spoke in favor. Others felt more information was necessary, including an account of the responsibilities and activities of the Pastor. Voting was tabled until the issue could be considered at a later Congregational meeting, with the information in hand prior to the meeting.

I had been preparing to find an additional source of income working with real estate in order to offset lost income. However, experience and learning revealed improbability of being a bivocational Pastor/flipper or Pastor/real estate agent.

When Rachel Love sadly resigned to pursue a more reasonable work situation, I needed to spend additional time with her to learn processes she had developed on her own and then cover in her departure. This also required my resignation from the Connecticut real estate licensure class in which I was enrolled.

Given the expressions in favor of retaining me as a full-time Pastor and the need to faithfully reimagen and creatively re-create ministry in a time of such fast-paced change, I am withdrawing my offer to reduce my position.

I have provided both our church's constitutional description of the role and responsibilities of a called Pastor as well as an outline of my duties and activities at First Lutheran, specifically. These can be found on the adjacent pages.

Constitution, congregations of the Evangelical Lutheran Church in America (ELCA)

Chapter 9.

ROSTERED MINISTER

- *C9.01. Authority to call a pastor shall be in this congregation by at least a two-thirds vote of voting members present and voting at a meeting legally called for that purpose. Before a call is issued, the officers, or a committee elected by [this congregation][the Congregation Council] to recommend the call, shall seek the advice and help of the bishop of the synod.
- *C9.02. Only a member of the roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America or a candidate for the roster of Ministers of Word and Sacrament who has been recommended for the congregation by the synodical bishop may be called as a pastor of this congregation.
- *C9.03. Consistent with the faith and practice of the Evangelical Lutheran Church in America,
 - a. Every minister of Word and Sacrament shall:
 - 1) preach the Word;
 - 2) administer the sacraments;
 - 3) conduct public worship;
 - 4) provide pastoral care;
- 5) seek out and encourage qualified persons to prepare for the ministry of the Gospel;
- 6) impart knowledge of this church and its wider ministry through distribution of its communications and publications;
- 7) witness to the Kingdom of God in the community, in the nation, and abroad; and
- 8) speak publicly to the world in solidarity with the poor and oppressed, calling for justice and proclaiming God's love for the world.
 - b. Each pastor with a congregational call shall, within the congregation:
- 1) offer instruction, confirm, marry, visit the sick and distressed, and bury the dead;
 - 2) relate to all schools and organizations of this congregation;
 - install regularly elected members of the Congregation Council;
 - 4) with the council, administer discipline; and
- 5) endeavor to increase the support given by the congregation to the work of the ELCA churchwide organization and of the New England Synod of the ELCA.
- *C9.04. The specific duties of the pastor, compensation, and other matters pertaining to the service of the pastor shall be included in a letter of call, which shall be attested by the bishop of the synod.
- ***C9.12.** The pastor of this congregation:

- a. shall keep accurate parochial records of all baptisms, confirmations, marriages, burials, communicants, members received, members dismissed, or members excluded from the congregation;
 - b. shall submit a summary of such statistics annually to the synod; and
- c. shall become a member of this congregation upon receipt and acceptance of the letter of call. In a parish of multiple congregations, the pastor shall hold membership in one of the congregations.
- *C9.13. The pastor(s) shall submit a report of his or her ministry to the bishop of the synod at least 90 days prior to each regular meeting of the Synod Assembly.
- *C9.14. The parochial records of this congregation shall be maintained by the pastor and shall remain the property of the congregation. The secretary of this congregation shall attest in writing to the bishop of this synod that such records have been placed in his or her hands in good order by a departing pastor before the installation of that pastor in another field of labor or the granting by the synod of retired status to the pastor.
- **C9.15.** Under special circumstances, subject to the approval of the synodical bishop and the concurrence of this congregation, a minister of Word and Sacrament of a church body with which the Evangelical Lutheran Church in America officially has established a relationship of full communion may serve temporarily as pastor of this congregation under a contract between the congregation and the pastor in a form proposed by the synodical bishop and approved by the congregation.
